WORKING GROUP OF THE CONSULTATIVE COUNCIL OF EUROPEAN PROSECUTORS (CCPE-GT)

Report of the 20th meeting Strasbourg, 27 – 28 February 2017

Document prepared by the Secretariat Directorate General I - Human Rights and Rule of Law

I. INTRODUCTION

- 1. The Working Group of the Consultative Council of European Prosecutors (CCPE-GT) held its 20th meeting in Strasbourg on 27-28 February 2017. The meeting was chaired by Mr Peter McCormick (Ireland), President of the CCPE.
- 2. The agenda and the list of participants are reproduced in Appendices I and II respectively.

II. COMMUNICATION BY THE PRESIDENT AND MEMBERS OF THE BUREAU AND WORKING GROUP OF THE CCPE

3. The President informed the members of the Working Group about the invitation to an international Conference on the "Binding Effect of Judicial Decisions", organised by the Supreme Court of the Czech Republic in co-operation with the Ministry of Justice, within the framework of the Czech Chairmanship of the Committee of Ministers of the Council of Europe. The Conference will be held from 19 to 21 June 2017 in Brno, the capital of the Czech judiciary, with the participation of the Presidents of the Supreme and Constitutional Courts of the Council of Europe member states, judges of European courts and leading academics. Mr Cédric Visart agreed to participate in this Conference.

III. PREPARATION OF THE OPINION NO. 12 ON THE RIGHTS OF VICTIMS, WITNESSES AND VULNERABLE PERSONS

- 4. The President presented to the Working Group members the draft structure of the Opinion (document CCPE-BU(2017)3), as well as the *aide-mémoire* for the Opinion (document CCPE-BU(2017)2). He also referred to the recommendations of the Bureau members, in particular that the Opinion had to be practical and concrete, should highlight an ideal model of the prosecutors' role in the protection of the rights of victims, witnesses and vulnerable persons, instead of describing the existing systems in member states.
- 5. As regards the title of the Opinion as adopted by the plenary meeting of the CCPE on 17-18 November 2016¹, which is "The rights of victims, witnesses and vulnerable persons", the CCPE-GT stated that prosecutorial practices should be reflected in the title. Therefore, the Working Group agreed on the following title: "The role of prosecutors in relation to the rights of victims and witnesses in criminal proceedings" adding that "victims and witnesses" was already covering vulnerable persons.
- 6. The CCPE-GT discussed in particular the following items:
 - protection of the rights of victims and witnesses in all phases of criminal procedure, as well as during the execution of court verdicts,
 - rights and obligations linked to reporting a crime.
 - the authority charged with receiving complaints about crimes,
 - the role of prosecutors related to the compensation of victims,
 - protection programmes for victims/witnesses,
 - special regimes for victims of certain types of crimes,
 - availability of adequate means and resources at the disposal of the prosecution services.

- interaction and cooperation between prosecutors and other public bodies and NGOs.
- international cooperation, in particular as regards offences committed abroad and their prosecution,
- development of international instruments for cooperation, e.g. sharing databases,
- assistance to international organisations, e.g. EUROJUST,
- joint investigation teams, judicial networks.
- 7. The Working Group agreed on a structure (document CCPE-GT(2017)1Prov1) and on the distribution of tasks among its members, as everyone volunteered to draft a specific chapter or sub-chapter of the final approved structure:
 - 1. Introduction: purpose and area of application of the Opinion by the Secretariat
 - 2. Definitions by Mr Antonio VERCHER NOGUERA
 - 3. The rights and duties of victims and witnesses and protective measures for them by Mr José Manuel SANTOS PAIS
 - 4. Role of prosecutors in protecting the rights of victims and witnesses:
 - 4.1 Role of the prosecutor in general by Ms Alessandra GIRALDI
 - 4.2 Duties (in general manner) of prosecutors towards victims and witnesses by Ms Alessandra GIRALDI
 - 4.3. Avoiding secondary victimisation and awareness by prosecutors by Mr Cédric VISART DE BOCARME
 - 4.4 Focus on attention to specific victims by Mr Cédric VISART DE BOCARME
 - 4.5 Use of special measures or procedures to protect victims/witnesses when giving evidence by Mr Davit MELKONYAN
 - 4.6 The role of prosecutors and other actors in the enforcement of these rights and in the case of their violation by Mr Ramazan KAYA
 - 5. Training by Mr Antonio MURA
 - 6. International cooperation by Mr Vladimir ZIMIN.
- 8. As regards the timetable, it was decided to send, by 30 April 2017 or earlier, all contributions to the Secretariat. It would prepare a consolidated version of the draft Opinion, having integrated all contributions, and would then send it to the Bureau. Subsequently, the Bureau would consider and revise the draft and send it back to the Secretariat, which would, by 30 May 2017, send it to the members of the Working Group for their comments. These comments would be expected by 10 June 2017, and would be considered during the next Working Group meeting.

IV. OTHER ITEMS

9. The next meeting of the Working Group would take place in Paris on 15-16 June 2017.
