#### CONTEXT

The roundtable "Strengthening local and regional democracy in Ukraine" will gather together the members of the delegation of Ukraine to the Congress of Local and Regional Authorities of the Council of Europe and representatives of national associations of local and regional authorities of Ukraine, as well as NGOs involved in the implementation of the local self-government reform in Ukraine.

The Congress of Local and Regional Authorities of the Council of Europe and the Ukrainian national authorities signed, in 2015, a Roadmap for the implementation of the Congress recommendation on local and regional democracy in Ukraine. As a result of the continuous political dialogue, a high-level delegation, chaired by Mrs Gudrun Mosler-Törnström, the President of the Congress, will participate in series of meetings on 21-22 November 2017 in Kyiv to discuss recent developments in the implementation of the Roadmap and the ongoing reforms in Ukraine.

The objective of the roundtable is to discuss with representatives of local and regional authorities and their associations the challenges faced in the process of reform and the priorities for enhanced decentralisation and local self-government.

The roundtable "Strengthening local and regional democracy in Ukraine" is organised by the Congress of Local and Regional Authorities of the Council of Europe within the project "Promoting local democracy in Ukraine" and the Council of Europe Action Plan 2015 - 2017 for Ukraine.
