Answer 73: The entrance to judicial body is done through the successful exams to the National School of Judges. Based on the provisions of Law no 2236/1994 (articles 2,3 and 4) the selection of the candidates is made by the following procedure: entrance exam, registration to the National School of Judges, a 18-month training in the School, appointment of the graduates as judicial officials. The attendance in the School is obligatory. After the end of the studies (18 months), the judges are appointed by a Presidential Decree and according to the needs of each region. The National School of Judges is a Legal Entîty of Public Law. It has administrative and financial independence and it is supervised by the Minister of Justice.

Answer 74: The training for judges is conducted by the National School of Judges, its duration is 18 months. The training is theoretical and practical and it's divided into two different phases.
