#### <u>Item 1</u>: Opening of the meeting and adoption of the draft agenda

- 1. The CDDH Drafting Group on freedom of expression and links to other human rights (CDDH-EXP) held its third meeting in Strasbourg from 25 to 27 April 2018. The list of participants is contained in <u>Appendix I</u>. The agenda as adopted appears in <u>Appendix II</u>.
- 2. The Chairperson Mr Hans-Jörg BEHRENS (Germany) welcomed everyone to the meeting and thanked them for the many (examples of) national practices which they had submitted. At present, 26 contributions had been submitted by member States and representatives of the civil society.
- 3. Mr. Alfonso DE SALAS, Head of the Human Rights Intergovernmental Cooperation Division, explained the current difficult budgetary situation of the Council of Europe which had serious repercussions on the organisation's work programme.

#### <u>Item 2</u>: Exchange of views with other relevant bodies of the Council of Europe

- 4. The following invitees:
  - Ms Carlien SCHEELE, Senior Gender Equality Adviser and Ms Cécile GRÉBOVAL Gender Equality Unit,
  - Ms Silvia GRUNDMANN, Head of the Division Media and Internet Governance and Mr Emir POVLAKIC, Steering Committee on Media and Information Society (CDMSI),
  - Ms Simona GRANATA-MENGHINI, Deputy Secretary, European Commission for Democracy through Law (Venice Commission),

explained about their relevant work and submitted comments to the preliminary text of the draft Guide, also providing useful references to additional documents that could be consulted when finalising the draft text.

5. Mr Stefano VALENTI, External Relation Officer, Secretariat of the European Commission against Racism and Intolerance (ECRI), and Mr Menno ETTEMA, No Hate Speech and Cooperation Unit, had already provided substantial input at the previous meeting.

# <u>Item 3</u>: Discussion on a Guide to good practices on the way of reconciling freedom of expression with other rights and freedoms, in particular in culturally diverse societies

6. Ms Merete BJERREGAARD, Secretary of the CDDH-EXP, first explained that the preliminary text to the draft Guide, which had been prepared under the supervision of the Chairperson, included as many as practicable of the examples of national practices which had been submitted (see Compilation, document CDDH-EXP (2018)02 dated 19 April 2018). The preliminary text of the draft Guide also took into account the relevant work undertaken by other sectors of the Council of Europe as well as by other international and regional organisations.

#### a) General discussion

7. The Group then held a general discussion on the preliminary text of the draft Guide to good practices. While noting that some of the national practices submitted had not yet been evaluated and thus could not yet be regarded as good practices, it was agreed in the title of the Guide to add "and promising" to the "good practices". The criteria for the selections of national practices to be included in the draft Guide should be explained in the introduction

where it should also be noted that the practices could not be regarded as exhaustive and that any evaluation of their effectiveness was not within the scope of the Group.

- 8. In a number of areas, the examples provided by the member States reflected different approaches to emerging challenges, which other member States may wish to reflect upon. Their inclusion in the guide is intended to show the variety of approaches and to give an impression of the diversity of possible responses in different national contexts.
- 9. In the light of the contributions received the Group agreed to make a few minor structural changes to the Guide while nevertheless maintaining the general structure as already agreed upon and approved by the CDDH.
- 10. Furthermore, it agreed to add to the draft Guide a section with conclusions which would draw up some general trends and mention the existing challenges (such as the absence of agreed definitions at the European level and the lack of data and research in respect of "information disorder [fake news]" and "hate speech").
- 11. Finally, the Group agreed that it was necessary to closely coordinate its work with the CDDH Drafting Group on Civil Society and National Human Rights Institutions (CDDH-INST).
  - b) Examination of the preliminary text
- 12. The Group had a first reading of the preliminary text of the draft Guide proceeding paragraph by paragraph. It proposed a number of changes both with regard to the content and the wording.
- 13. Under the supervision of the Chairperson, the Secretariat was asked to include the specific changes made at the meeting into a revised text of the draft Guide which would be sent to the participants. The participants would be given a week to check the revised text.
  - c) Next steps towards finalising the draft Guide
- 14. The Chairperson would report to the CDDH Bureau meeting on 17-18 May, and to the CDDH meeting on 19-22 June, on the outcome of the Group's drafting work. He would also draw attention to areas where additional good practices would be welcome. The Group would appreciate any guidance that the CDDH could provide with a view to finalising the draft text at its next meeting.

#### <u>Item 4</u>: Exchange of views on proposals for follow-up

- 15. The Group discussed the need for any follow-up work on freedom of expression and links to other human rights on the basis of the notes presented by the Secretariat. The Group noted that in this field much work had already been undertaken by other sectors of the Council of Europe, in particular the CDMSI, as well as by other international and regional organisations.
- 16. In particular, the Group noted the need expressed by PACE and ECRI for further clarifications regarding the definitions of hate speech and for strengthening cooperation between States in tackling transfrontier dissemination of hate speech, whether offline or online.
