#### Working Methods

- The <u>draft Analysis</u>, prepared by the Secretariat for the 2<sup>nd</sup> meeting of the CDDH-SOC, is to give a factual overview over the legal framework of the Council of Europe for the protection of social rights (<u>first report</u>). Proposals, as appropriate, with a view to improving the implementation of social rights and to facilitate in particular the relationship between the Council of Europe instruments with other instruments for the protection of social rights, will be the subject of a second report.
- Ms Chantal GALLANT, the former Rapporteur of the Drafting Group, has joined the Secretariat of the Council of Europe (Department for the Execution of Judgments of the European Court of Human Rights) and ended her work as a Rapporteur. The draft Analysis of the legal framework of the Council of Europe for the protection of social rights in Europe (first report) and the subsequent report containing proposals, as appropriate, with a view to improving the implementation of social rights (second report) will therefore be presented to the Drafting Group as reports of the Secretariat, following approval by the Chairperson, as a basis for the work of the CDDH-SOC.
- Written contributions/comments from the experts are encouraged, as they can be circulated in

due time and analysed by the other experts, the Chairperson and the Secretariat before the meeting.

### **Planning**

- The <u>draft provisional planning</u> is proposed so as to allow the CDDH-SOC to fulfil its terms of reference for the biennium 2018–2019.
- The <u>main objective of the 2<sup>nd</sup> meeting</u> is to review the draft Analysis paragraph by paragraph. The CDDH-SOC may then choose to send the draft Analysis to the CDDH for adoption at its 89<sup>th</sup> meeting in June 2018.
- Regarding the <u>questionnaire</u>, a summary of the replies received as well as a short analysis thereof will be circulated to all experts in due time before the 2<sup>nd</sup> meeting of the CDDH-SOC. This analysis may be used in the work on the second report to reflect national developments and how member States are implementing social rights (possibly in a separate chapter). Therefore, at the 2<sup>nd</sup> meeting, the CDDH-SOC is invited to exchange views on the replies to the questionnaire and the analysis thereof, in view of its possible future inclusion in the second report.
- A first exchange of views on the possible structure and contents of the second report shall be held at the 2<sup>nd</sup> meeting on the basis of a <u>draft Overview over the possible contents of the second report</u> prepared by the Secretariat.
- Provided the CDDH-SOC and/or the CDDH instruct it to do so, the Secretariat will prepare <u>basic</u> fundamental preparatory work for the second report following the 89<sup>th</sup> CDDH meeting in June 2018.
