# **TENDER FILE / TERMS OF REFERENCE**(Competitive bidding procedure/ One-off contract)



## Purchase of animated video development services Contract N° BH 8709/2021/11

The Council of Europe is currently implementing the Project Promoting European standards in the audio-visual regulation of the Republic of Moldova, until December 2021. Among its objectives, the Project aims to foster the independence of the National Public Broadcaster, Teleradio-Moldova, including via strengthening the Ombudsman Service of the public company. In that context, the project is looking for a Provider to provide video development services to create a 30-seconds' animated video spot for the National Public Broadcaster, Teleradio-Moldova to raise the awareness about the existent Audience Ombudsperson Service at Teleradio-Moldova. For more details, see Section A of the Act of Engagement.

## A. TENDER PROCEDURE RULES

This tender procedure is a competitive bidding procedure. In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe¹, the Organisation shall invite to tender at least three potential providers for any purchase between €2,000 (or €5,000 for intellectual services) and €55,000 tax exclusive.

This specific tender procedure aims at concluding a **one-off contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 120 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be a legal person or consortia of legal and/or natural persons.

Tenders shall be submitted by email only (with attachments) to the email address indicated in the table below, with the following reference in subject: Tender – Animated video development offer. Tenders addressed to another email address will be rejected.

The general information and contact details for this procedure are indicated on this page. You are invited to use the Council of Europe Contact details indicated below for any question you may have. All questions shall be submitted at least <u>five working days before the deadline for submission of the tenders</u> and shall be exclusively addressed to the email address indicated below with the following reference in subject: Questions — Animated video development offer

#### B. EXPECTED DELIVERABLES

The expected deliverables are described in **Section A of the Act of Engagement** (see attached).

#### C FFFS

All tenderers are invited to fill in the **table of fees** as reproduced in **Section A of the Act of Engagement**.

Tenderers <u>subject to VAT</u> shall also send a **quote (Pro Forma invoice)** on their letterhead including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services to be provided;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive.

## D. ASSESSMENT

Exclusion criteria and absence of conflict of interests

(by signing the Act of Engagement,<sup>2</sup> you declare on your honour not being in any of the below situations) Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering, terrorist financing, terrorist offences or offences linked to terrorist activities, child labour or trafficking in human beings;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are or are likely to be in a situation of conflict of interests.

## Eligibility criteria

- Being a registered company in the field of video and motion graphic production services with at least 3 years of experience.
- Proven track record of production of animated videos for international organisations, media outlets or public institutions.

#### Award criteria

- Quality of the offer (60%), including:
  - Company portfolio with samples of animated/graphic videos developed (at least 3 samples for various stakeholders);
  - Capacity to meet the deadline as set out in the Act of Engagement (proven by a document explaining the plan and timeline for the provision of expected deliverables)
- Financial offer (40%).

Multiple tendering is not authorised.

## E. NEGOTIATIONS

The Council reserves the right to hold negotiations with the bidders in accordance with Article 20 of Rule 1395.

#### F. DOCUMENTS TO BE PROVIDED

Tenderers are invited to submit:

- A completed and signed copy of the Act of Engagement<sup>3</sup> (see attached)
- For tenderers subject to VAT <u>only</u>: a quote, describing their financial offer, in line with the requirements of section C of the Tender File (see above);
- · Registration documents, for legal persons only;
- Company Portfolio showcasing previous experience in developing animated/graphic video spots (at least 3 samples for various stakeholders);
- Plan and Timeline for the provision of expected deliverables.

All documents shall be submitted in English (with the exception of registration documents and the video samples provided), failure to do so will result in the exclusion of the tender.

If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.

The Council reserves the right to reject a tender if the scanned documents are of such a quality that the documents cannot be read once printed.
