CONTEXT

The thematic roundtable "Good Governance in Metropolitan Areas in Ukraine and in Europe" is organised in Ukraine by the Congress of Local and Regional Authorities of the Council of Europe within the project "Promoting local democracy in Ukraine" and the Council of Europe Action Plan 2015 - 2017 for Ukraine.

European metropolitan areas are increasingly becoming a dominant force in terms of political, economic and cultural activity, acting as engines of development and economic success. Moreover, the rising significance of metropolitan regions has become a distinctive and striking trend across Europe that requires further analysis and sharing experiences.

In this regard, the aim of the Roundtable is to provide Ukrainian local and regional elected representatives with the opportunity to exchange experiences with European counterparts on metropolitan governance models and practices in metropolitan areas, as well as to discuss key challenges for such cities.

OBJECTIVES

The Roundtable aims to:

- Share knowledge and exchange experiences about models of good governance in European metropolitan areas;
- Share experiences on the decentralisation of powers from the national to the local level and its implementation;
- Discuss the distribution of powers and competences allocated to city and district councils within the municipality;
- Discuss the role and responsibilities of local and regional elected representatives regarding good governance practices as well as inclusive and participative decisionmaking processes.
