**Operationalising the Strategic Plan's indicators – next steps**

At its first meeting on 10<sup>th</sup> April 2024, the Working Group considered document T-PVS/Inf(2024)10 on <u>Advancing work on indicators for the Strategic Plan</u>, which provides updated details of the suggested approach, metrics, data sources, baseline considerations, linkages, responsibilities and other information (to varying degrees) for each of the sixteen agreed indicators in the Plan.

At its second meeting on 29<sup>th</sup> August 2024, the Working Group considered document T-PVS(2024)06 <u>Strategic Plan indicators – results of Working Group consultation April-May 2024, and next steps</u>, which included suggestions for specific actions to be taken to bring each of the indicators into practical operation. The table below now presents a revised list of these actions as agreed by the August meeting, incorporating input from the Working Group.

Document T-PVS(2024)06 showed that the different indicators are at varying states of potential readiness, so the timeframes for completing the suggested next actions will also vary. More detail on this will be developed as the Working Group continues its work, but the actions listed below provide a near-immediate starting point for arranging to measure progress on the adopted targets in the Plan.
