Training of Trainers on SLAPPs for Judicial Institutes

Journalists Matter Campaign – Prosecution Pillar

As part of the 2025 activities under the <u>Journalists Matter Campaign</u>, the Prosecution Pillar focuses inter alia on enhancing the ability of judicial professionals to address Strategic Lawsuits Against Public Participation (SLAPPs)—a growing tool used to silence independent journalism through abuse of legal systems. Judges and prosecutors play a critical role in safeguarding press freedom by ensuring that courts are not misused to intimidate journalists.

To ensure sustainable, peer-led change at the national level, the Council of Europe, in cooperation with and generously hosted by the Czech Government, is organising a *Training of Trainers (ToT)* for judicial training institutes from member States. The event will take place on 9–10 October 2025 at the Government Palace (Hrzánský Palace) in Prague.

This initiative will:

- Equip representatives of judicial institutes with the necessary knowledge to deliver nationallevel trainings on SLAPPs.
- Enable participants to identify and recognise SLAPPs
- Go in depth into the <u>Council of Europe Recommendation CM/Rec(2024)2</u> of the Committee of Ministers to member States on the protection of the right to freedom of expression in the context of Strategic Lawsuits Against Public Participation (SLAPPs), by examining and explaining the guidance it contains and its relevance for judicial training, and application in national contexts.
- Promote exchange and collaboration among judicial institutions from Council of Europe member states.
- Raise awareness among the public and policy actors through participation in the *Press Play Prague Film Festival*. The cultural programme, organised in cooperation with the festival and with the support of the Czech Government, will further connect the professional discussions with a broader public dialogue on the protection of journalists.

By supporting national institutions in integrating SLAPPs into their training curricula, this activity aims to build long-term capacity in judicial systems to protect journalists' rights and more widely media freedom and freedom of expression.

Strategic Lawsuits Against Public Participation ("SLAPPs") are legal actions that are threatened, initiated, or pursued with the intent to harass or intimidate their targets, aiming to prevent, restrict, or punish free expression on matters of public interest and the exercise of related rights. SLAPPs can significantly affect not only the individuals targeted but also the broader democratic space by suppressing watchdog activities, investigative journalism, and civic participation.

These lawsuits have serious consequences: they can stifle individual expression and undermine the free exchange of ideas essential to a democratic society. SLAPPs often result in self-censorship, as individuals and organisations refrain from publishing information or pursuing investigations due to the legal and financial risks involved. As a result, the public may be deprived of access to information of significant public value.

To address this threat, the European Union and the Council of Europe adopted key instruments in 2024:

- EU Directive 2024/1069 on the protection of persons who engage in public participation from manifestly unfounded claims or abusive court proceedings
- Council of Europe Recommendation CM/Rec(2024)2 on countering the use of SLAPPs

Building on these instruments, the Council of Europe has developed the first European Curriculum on Countering SLAPPs, a comprehensive training resource designed for judges, prosecutors, lawyers, journalists, and civil society actors. The curriculum is grounded in both EU and Council of Europe standards, including the case law of the European Court of Human Rights.

As part of efforts to promote the effective implementation of these standards, a Training of Trainers (ToT) session will take place on 9–10 October 2025. This training is specifically designed for trainers affiliated with national judicial institutes who will be in a position to deliver further trainings on SLAPPs at the national level. The objective is to equip these trainers with the legal knowledge, tools, and pedagogical strategies necessary to raise awareness among judges, prosecutors, and other legal professionals about SLAPPs and how to address them using the latest European legal instruments and jurisprudence.

The training will be delivered by Council of Europe consultants Ms Flutura Kusariand Ms Dominika Bychawska-Siniarska.
