4. maintain great vigilance regarding the development close to the falls, e.g. installations or extension of shops, as well as medical care and new touristic activities (e.g. ice-climbing);

Is implemented and an ongoing process. In all of nature conservation law administrative procedures, which take place in the surroundings to the Krimml Waterfalls, always takes a rigorous examination of the potential impact on the natural monument. There are no new touristic activities or attractions installed.

The general maintenance work on the footpath is an ongoing process. This work will be implemented with great care on the landscape for the safety of visitors and for the visitor management.

7. pursue scientific research and secure funding for studies on regional birdlife, fungi (including lichens) and bryophytes, as a contribution to protect the area's typical biodiversity;

Due to COVID-19 pandemic situation there was a significant decrease of visitors, especially due to a shorter visiting season.

Next to the European Diploma holding area and the starting point of the four kilometer long waterfall hike there is the Worlds of Water. This innovative exhibition area is a combination of edutainment, sensory experiences and active participation. The grandiose panoramic terrace in the WasserBar reveals spectacular views of the waterfalls. The exhibition area is dedicated to infotainment with exciting experiments and a new WaterCinema. In the outdoor area, visitors can get active themselves. Fun games make for plenty of enjoyment with the wet element. The centrepiece of the Worlds of Water is the modern waterfall centre: The Aquaszenarium is a projection show, the only one of its kind in Austria, and a cracker for young and old alike. The floor and walls are covered with projections, which can be manipulated and changed by touch or by stepping onto them. With this multimedia setup, visitors can playfully immerse themselves into the four water worlds: Beginning with the water meadow landscape at the upper falls of the river, where you can play interactively with projected butterflies, grasses and fish
