To adopt the draft decisions hereafter.

At their last meeting on 4 November 2015, the Deputies examined a first set of draft decisions on the follow-up to be given to the above-mentioned thematic debate in the light of proposed amendments submitted by two delegations (see DD(2015)1163 and DD(2015)1164).

At the close of the discussion, the Deputies agreed to resume consideration of this item at the present meeting, following consultations to be conducted by the Chair in the meantime.

In accordance with this decision, the Chair has conducted consultations and in the light of these, proposes to adopt the draft decisions below.

Financing assured: The possible establishment of a mechanism for the protection of human rights defenders is not covered by the draft Programme and Budget for 2016-2017.

Thematic debate: "Freedom of assembly and association: current challenges and the response from the Council of Europe" – Follow-up

**Decisions** 

The Deputies

- 1. recalled the obligation of member States, in accordance with Article 11 of the European Convention on Human Rights and the relevant jurisprudence of the European Court of Human Rights, to ensure respect for the right to freedom of assembly and association, the exercise of which cannot be subject to restrictions other than those provided for in paragraph 2 of this Article; recalled also that this involves a positive obligation for member States to create a favourable environment for the exercise of that freedom;
- 2. underlined the particular importance they attach to this freedom which is key for democracy and for the full and effective exercise of other fundamental freedoms, and commended in this context the invaluable contribution of **civil society**, **including** non-governmental organisations and human rights defenders;
- 3. expressed their determination to secure the full exercise of freedom of assembly and association implementation of Article 11 of the European Convention on Human Rights within the geographical area of the Council of Europe, in line with and recalled the relevant declarations and recommendations adopted by the Committee of Ministers in this field, in particular the Declaration on Council of Europe action to improve the protection of human rights defenders and promote their activities and Recommendation CM/Rec(2007)14 on the legal status of non-governmental organisations in Europe;
- 4. welcomed the efforts deployed to this end by the Commissioner for Human Rights and encouraged him to continue his action:
- 5. expressed their serious concern regarding undue restrictions placed on the creation, functioning and financing of non-governmental organisations as well as concerning attacks on and violations of the rights of **civil society representatives**, **including** human rights defenders, in Council of Europe member States or elsewhere:
- 6. <u>called on encouraged</u> member States to review their domestic legislation and practice regarding freedom of assembly and association in order to ensure that they meet the requirements posed by **Article 11 of the European Convention on Human Rights and other** the relevant Council of Europe instruments and respond to, with due regard to conclusions and recommendations of its monitoring bodies;
- 7. encouraged member States to make use of the expertise of the Council of Europe to this end and to examine all appropriate ways of promoting the participation of civil society in democratic governance;
- 8. welcomed the increased focus proposed by the Secretary General on the promotion of freedom of assembly and association and of the participation of civil society in democratic governance in the Programme and Budget for 2016-2017, in particular through the preparation of guidelines on civil participation in political decision-making;
- 9. invited also the Secretary General to:
- (i) examine the feasibility of a protection mechanism for human rights defenders, taking into account **its financial implications in the context of the programme and budget and the need to avoid overlapping with** existing initiatives, with a view to submitting operational proposals in this respect;
- (ii) prepare an overview of good practices in respect of promoting freedom of assembly and association and of the contribution of civil society to democratic governance, on the basis of a compilation of national legislation, including regarding the foreign funding of NGOs, and the results conclusions and recommendations of the monitoring mechanisms. , with a view to its widest possible dissemination.

Appointment of a member and reappointment of the deputy to the member of ECRI in respect of Monaco

#### Item to be prepared by the GR-H on 17 November 2015

#### Action – Item proposed for adoption without debate<sup>2</sup>

To take note of the names and curricula vitae of the persons appointed by Monaco to serve as member and deputy to the member of ECRI in respect of that country for a term of office of five years, starting on 7 December 2015.

- On 13 June 2002, the Ministers' Deputies adopted Resolution Res(2002)8 on the Statute of ECRI. In accordance with Article 2 of ECRI's Statute, the members of ECRI should have high moral authority and recognised expertise in dealing with racism, racial discrimination, xenophobia, antisemitism and intolerance. They should serve in their individual capacity and should be independent and impartial in fulfilling their mandate. They should not receive any instructions from their government.
- In accordance with Article 3.3 of ECRI's Statute, if the Committee of Ministers considers that the appointment of one or more members of ECRI would not be in conformity with the provisions of Article 2 of ECRI's Statute, it will ask the member State(s) concerned to make another appointment.
- In accordance with Article 3.6 of the Statute, the members of ECRI shall be appointed for a term of office of five years, which may be renewed twice. During their term of office, they may only be replaced if they have tendered their resignation, or are no longer able to exercise their functions.
- In accordance with Article 4 of the Statute, if the Government so wishes, a deputy to the ECRI member may be appointed. The provisions of Articles 2 and 3 of the Statute shall also apply to the appointment of deputy members except that their mandate shall in all cases expire at the same time as that of the ECRI member.
- Document DGII/Inf(2015)6 reproduces the curricula vitae of the persons appointed by the authorities of Monaco as member and deputy to the member of ECRI. They were communicated to the Secretary General together with the appointment notifications.
- The GR-H will examine this appointment and reappointment at its meeting on 17 November 2015 6. with a view to formulating a recommendation to the Deputies.

#### Action - Item proposed for adoption without debate

To appoint 1 member and 3 alternate members of the Ad hoc Committee of Experts on Buildings (CAHB) for the period until 31 March 2018. To invite member States to submit candidatures for the remaining vacancies of 2 members and alternate members as a matter of priority and, pending completion of the appointment procedure, to authorise the CAHB to exercise its terms of reference.

- 1. The composition of the Ad hoc Committee of Experts on Buildings is laid down in Article 5 of the terms of reference of the CAHB (cf. CM(2015)28 final). Consequently, a member and alternate member shall be appointed upon nomination by the governments of each of the major contributor member States to the general budget for the Organisation. The other members and their alternate members are to be appointed upon nomination by the governments of other member States. Alternate members are appointed in respect of each state whose candidate is appointed a titular member insofar as the States concerned nominate candidates for alternate members.
- 2. To date, five experts have been appointed upon nomination by the major contributor member States (France, Germany, Italy, Russian Federation and United Kingdom) and three others upon nomination by other member States (Spain, Switzerland and Turkey). Seven alternate members still remained to be appointed. A new call for candidatures for the remaining members and alternate members was launched with a deadline of 30 October 2015.
- 3. The Secretary to the Committee of Ministers has since received notification of the following candidates:
- Mr Alexei Ochnev as alternate member on behalf of the Russian Federation (CM(2015)54 add10);
- Ms Hanni Sippo as member on behalf of Finland (CM(2015)54 add11).
- Mr Luis Eduardo Bardon Rubio as alternate member on behalf of Spain (CM(2015)54 add12);
- Ms Catherine Arnold as alternate member on behalf of the United Kingdom (CM(2015)54 add13).
- 4. It is proposed that the Deputies approve the nomination of the above candidates bringing the total number of members to 9 and invite member States to submit candidatures for the remaining 2 members as a matter of priority. Updated information on the call for candidatures is set out in Appendix to these notes.
- 5. The CAHB's next meeting is scheduled for early 2016. Should the remaining 2 members not be nominated before then, the Deputies are invited to authorise the CAHB to nevertheless exercise its mandate.

Appendix: Information on the call for candidatures<sup>2</sup> for appointment of members and alternate members of the Ad hoc Committee of Experts on Buildings (CAHB) of the Council of Europe

**Function**: 2 members and 4 alternate members of the Ad hoc Committee of Experts on Buildings (CAHB) of the Council of Europe.

**Required qualifications**: trained architects or engineers and/or experience in real-estate management (*Article 5.d of the terms of reference*).

**Nationality:** the 2 remaining members must be nationals of different member States<sup>3</sup>. Two alternate members shall also be appointed in respect of each State whose candidate is appointed member. Additionally, 1 alternate member is still to be appointed in respect of Switzerland and 1 alternate member to be appointed in respect of Finland.

**Term of office**: three years, renewable (*Article 5.a of the terms of reference*). The term of office of the CAHB began on 1 April 2015.

Working languages: the official languages of the Council of Europe are English and French.

**Meetings:** the CAHB meets at least once a year (*Article 6 of the terms of reference*); each meeting lasts between 1 and 3 days, according to the workload.

**Allowances**: the reimbursement of travel and subsistence expenses of the members of the CAHB is subject to the Council of Europe rules. The daily allowance has been set for each meeting day at €175 for 2015 (50% for hotel accommodation, 15% for each main meal and 20% for miscellaneous expenses). Travel expenses are reimbursed under certain conditions. The members of the CAHB receive no remuneration.

**Department/authority responsible for receiving candidatures**: the Secretariat of the Committee of Ministers of the Council of Europe. The candidature may also reach the Council of Europe by electronic mail to the Secretariat of the Committee of Ministers (CM@coe.int).

**Gender balance**: Recommendation Rec(81)6 on the participation of women and men in an equitable proportion in committees and other bodies set up in the Council of Europe should be borne in mind when submitting candidates.
