

**RESOLUTION (90) 26**

**on the adjustment of the scale of contributions  
to the budget of the Partial Agreement on the  
European Commission for Democracy through Law  
with effect from 1 January 1991**

(adopted by the Committee of Ministers on 30 November 1990  
at the 449th meeting of the Ministers' Deputies)

The Committee of Ministers under the terms of Article 38 of the Statute of the Council of Europe and with membership restricted to the Representatives of the States of the Council of Europe which are members of the Partial Agreement on the European Commission for Democracy through Law (1),

**HAVING REGARD** to Resolution (90) 6 of 10 May 1990 setting up a Partial Agreement on the European Commission for Democracy through Law;

**HAVING REGARD** to Resolution (74) 25 as amended by Resolutions (78) 50 and (78) 72;

**HAVING REGARD** to the Secretariat's proposals set out in document CM (90) 143;

**CONSIDERING** that, in consequence, the scale of contributions by member States to the budget of the Partial Agreement on the European Commission for Democracy through Law for the period 1991-1992 needs to be fixed with effect from 1 January 1991,

**RESOLVES AS FOLLOWS:**

The scale of contributions by member States to the budget of the Partial Agreement on the European Commission for Democracy through Law as appended to this resolution is adopted with effect from 1 January 1991 for the financial years 1991-1992.
