

RESOLUTION (64) 20

(Adopted by the Ministers' Deputies on 8th December 1964)

PARTIAL AGREEMENT ON THE RESETTLEMENT FUND

- Approval of the 1963 accounts -

The representatives on the Committee of Ministers of the member States of the Council of Europe Resettlement Fund for National Refugees and Over-Population¹;

Having regard to Resolution (56) 9 on the adoption of the Articles of Agreement of the Council of Europe Resettlement Fund;

Having regard to the accounts of the Partial Agreement on the Resettlement Fund for the year 1963 as submitted by the Secretary-General, comprising :

- (a) The Appropriation Account,
- (b) The Cash Account,
- (c) The Final Account;

Having regard to the Secretary-General's memorandum of 2nd September 1964, to which these accounts are appended;

Having regard to the Auditors' report of 26th May 1964,

Resolve as follows :

- I. The following accounts, as set out in the table submitted by the Secretary-General, are hereby approved :

1. Belgium, Cyprus, France, Federal Republic of Germany, Greece, Iceland, Italy, Luxembourg and Turkey.

- (a) The Appropriation Account for the Financial Year 1963,
- (b) The Cash Account for the Financial Year 1963,
- (c) The Final Account.

II. The Secretary-General is discharged of his financial responsibility for the Financial Year 1963.

III. The distribution between member States of the Resettlement Fund of the sum of 17,815.71 francs, being the credit balance from the Financial Year 1963 due to these countries, is approved, in accordance with the appended table.

The credit balance for the Financial Year 1963 of 17,815.71 francs shall be credited to the budget of receipts for the Financial Year 1964.
