

RESOLUTION (89)36

**amending the scale for contributions to the budget of the
Partial Agreement on the Co-operation Group to combat drug
abuse and illicit trafficking in drugs (Pompidou Group)
following the admission of Cyprus**

(adopted by the Committee of Ministers on 5 December 1989
at the 431st meeting of the Ministers' Deputies)

The Committee of Ministers, under the terms of Article 38 of the Statute of the Council of Europe and with membership restricted to Representatives of the States of the Council of Europe which are members of the Co-operation Group to combat drug abuse and illicit trafficking in drugs (Pompidou Group) (1),

HAVING REGARD to Resolution (74)25 as amended by Resolutions (78)50 and (78)72;

HAVING REGARD to Resolution (88)21 of 28 November 1988 fixing the scale of States' contributions to the budget of the Partial Agreement on the Co-operation Group to combat drug abuse and illicit trafficking in drugs (Pompidou Group);

CONSIDERING that as a result of the admission of Cyprus to membership of the Partial Agreement on the Co-operation Group to combat drug abuse and illicit trafficking in drugs (Pompidou Group), the scale of contributions by member States to this Partial Agreement for 1990 needs to be adjusted with effect from 1 January 1990,

RESOLVES AS FOLLOWS :

The table appended hereto shall replace the table reproduced in the Appendix to Resolution (88)21, as from 1 January 1990.

(1) States concerned: Austria, Belgium, Cyprus, Denmark, Finland, France, Federal Republic of Germany, Greece, Ireland, Italy, Luxembourg, Malta, Netherlands, Norway, Portugal, Spain, Sweden, Switzerland, Turkey and United Kingdom.
