### **RESOLUTION (81) 24**

#### **CONCERNING THE PARTIAL AGREEMENT ON THE RESETTLEMENT FUND ACCOUNTS FOR THE FINANCIAL YEAR 1980**

*(Adopted by the Committee of Ministers on 23 November 1981  
at the 340th meeting of the Ministers' Deputies)*

The Committee of Ministers, under the terms of Article 16 of the Statute of the Council of Europe, and with membership restricted to the Representatives of the states of the Council of Europe which are members of the Resettlement Fund,<sup>1</sup>

Having regard to the accounts of the Partial Agreement on the Resettlement Fund for 1980, as submitted by the Secretary General, namely :

- a.* the budget management account,
- b.* the balance-sheet at 31 December 1980 ;

Having regard to the Secretariat memorandum presenting these accounts ;

Having regard to the Auditors' report of 4 June 1981 (Doc. CM (81) 165),

Resolves as follows :

1. The accounts for 1980 as set out in the tables submitted by the Secretary General, are approved.
2. The unexpended balances of the appropriations for 1980, amounting to 249 052.67 F as shown in the statement submitted by the Secretary General, are cancelled.
3. The Secretary General is hereby discharged from his financial responsibility in respect of the financial year 1980.
4. Approval is hereby given to the manner shown in the appended table of apportioning the credit balance of 249 052.67 F for the financial year 1980 among the states which are members of the Resettlement Fund.
5. This amount will be treated as an advance payment on member states' contributions to the Partial Agreement budget for 1982.
