PARTIAL AGREEMENT IN THE SOCIAL FIELD

Accounts for 1968

The Representatives on the Committee of Ministers of the states which are Parties to the Partial Agreement in the social field¹:

Having regard to Resolution (59) 23, point V;

Having regard to the accounts of the Partial Agreement in the social field for the financial year 1968, as submitted by the Secretary General, comprising :

- (a) the Appropriation Account;
- (b) the Cash Account;
- (c) the Final Account;

Having regard to the Secretary General's memoran dum presenting these accounts;

Having regard to the Auditors' report of 11 June 1969,

Resolve as follows :

1. The following accounts, as set out in the tables submitted by the Secretary General, are hereby approved :

(a) the Appropriation Account for the financial year 1968;

(b) the Cash Account for the financial year 1968;

(c) the Final Account for the financial year 1968;

2. The unexpended balance of the appropriations for 1968, amounting to 1,815.70 F, as shown in the statement submitted by the Secretary General, is hereby cancelled;

1. Belgium, France, Federal Republic of Germany, Italy, Luxembourg, Netherlands and United Kingdom.

3. The Secretary General is hereby discharged from his financial responsibility in respect of the financial year 1968;

4. Approval is hereby given to the manner shown in the table appended of apportioning the credit balance of 14,315.70 F. for the financial year 1968 among the participating states. The total due to the participating states shall be credited to the 1970 budget of receipts.
