RESOLUTION (83) 16

CONCERNING THE EUROPEAN PHARMACOPOEIA ACCOUNTS FOR THE FINANCIAL YEAR 1982

*(Adopted by the Committee of Ministers on 28 November 1983
at the 365th meeting of the Ministers' Deputies)*

The Committee of Ministers, under the terms of Article 16 of the Statute of the Council of Europe, and with membership restricted to the Representatives of the States Parties to the Convention on the Elaboration of a European Pharmacopoeia¹,

Having regard to the accounts of the Pharmacopoeia for the financial year 1982, as submitted by the Secretary General, comprising :

- a. the budget management account ;
- b. the balance-sheet at 31 December 1982 ;

Having regard to the Secretariat memorandum presenting the accounts ;

Having regard to the Auditors' Report of 10 June 1983 (Doc. CM (83) 94),

Resolves as follows :

1. The accounts for 1982, as set out in the tables submitted by the Secretary General, are approved.
2. The unexpended balances of the appropriations for 1982, amounting to 336 902.12 FF as shown in the statement submitted by the Secretary General, are cancelled.
3. The Secretary General is hereby discharged from his financial responsibility in respect of the financial year 1982.
4. Approval is hereby given to the manner shown in the appended table of apportioning the credit balance of 544 245.99 FF for the financial year 1982 among the member states.
5. This amount will be treated as an advance payment on member states' contributions to the Partial Agreement budget for 1984.

1. Austria, Belgium, Cyprus, Denmark, France, Federal Republic of Germany, Iceland, Ireland, Italy, Luxembourg, Netherlands, Norway, Sweden, Switzerland and United Kingdom.
