RESOLUTION (91) 4

CONCERNING THE BUDGET OF THE PARTIAL AGREEMENT ON THE EUROPEAN COMMISSION FOR DEMOCRACY THROUGH LAW FOR 1991

(Adopted by the Committee of Ministers on 17 January 1991 at the 451st meeting of the Ministers' Deputies)

The Committee of Ministers, under the terms of Article 16 of the Statute of the Council of Europe and with membership restricted to the Representatives of the states of the Council of Europe which are members of the Partial Agreement on the European Commission for Democracy through Law,¹

Having regard to Resolution (90) 6 of 10 May 1990 on a Partial Agreement establishing the European Commission for Democracy through Law;

Having regard to Articles 19, 21 and 28 of the Financial Regulations;

Having regard to Resolution (90) 46, approving the budget of the Partial Agreement on the European Commission for Democracy through Law for 1991;

Having regard to Resolution (90) 26 of 30 November 1990, fixing the scale of contributions of member states to the budget of the Partial Agreement on the European Commission for Democracy through Law, as last amended by Resolution (91) 3;

Considering that, in consequence, it is necessary to adjust the apportionment between the member states of the Partial Agreement on the European Commission for Democracy through Law of the contributions for the financial year 1991 totalling 1 478 000 FF as they appear in Table C appended to Resolution (90) 46,

Resolves as follows:

Approval is hereby given to the apportionment, between the states which are members of the Partial Agreement on the European Commission for Democracy through Law, of the contributions for 1991 totalling 1 478 000 FF according to Table C appended hereto, which cancels and replaces Table C appended to Resolution (90) 46.
