## **RESOLUTION** (74) 36

## CONCERNING THE PARTIAL AGREEMENT ON THE RESETTLEMENT FUND ACCOUNTS FOR THE FINANCIAL YEAR 1973

(Adopted by the Committee of Ministers on 12 December 1974, at the 240th meeting of the Ministers' Deputies)

The Representatives on the Committee of Ministers of the states which are members of the Council of Europe Resettlement Fund for National Refugees and Over-Population in Europe,<sup>1</sup>

Having regard to Resolution (56) 9 on the adoption of the Articles of Agreement of the Council of Europe Resettlement Fund;

Having regard to the accounts for 1973 on the Partial Agreement on the Resettlement Fund, as submitted by the Secretary General, namely :

a. the budgetary management accounts;

b. the balance sheet at 31 December 1973;

Having regard to the Secretariat's memorandum presenting these accounts;

Having regard to the Auditors' report of 20 June 1974,

Resolve as follows :

I. The accounts, as set out in the tables submitted by the Secretary General for the financial year 1973, are approved.

II. The unexpended balances of the appropriations for 1973, amounting to 32 256.11 F, as shown in the statement submitted by the Secretary General, are cancelled.

III. The Secretary General is hereby discharged from his financial responsibility in respect of the financial year 1973.

IV. Approval is hereby given to the manner shown in the appended table of apportioning the credit balance of 76 391.37 F for the financial year 1973 among the states which are members of the Resettlement Fund. The amount due to the member states will be credited to the 1974 budget receipts.
