

*Re: the execution of the Court's judgment
in the case of Oleksandr Volkov v. Ukraine*

Dear Madam,

Further to the information previously submitted to the Committee of Ministers of Council of Europe (hereinafter – the Committee) on the execution of the Court's judgment in the case of *Oleksandr Volkov v. Ukraine*, application no. 21722/11, the Government would like to provide an update as to the execution of Court's judgments in this case.

In their last letter the Government informed the Committee that the costs and expenses in the amount of 11,171.48 euro (of 12,000 euro of costs and expenses awarded by the Court) were paid to the applicant's representatives. The remainder of this sum, namely 828.52 euro, were paid to the applicant's representative on February, 28, 2014. However, the default interest with respect of costs and expenses is still pending.

As to the reinstatement of the applicant, the Government referred in their earlier submissions to the draft Resolution of the Verkhovna Rada of Ukraine "On execution of § 9 of Court' judgment in the case of *Oleksandr Volkov v. Ukraine* (Application no. 21722/11)", no 4446, which was pending before the Parliament. This draft Resolution was discussed at the plenary sessions of the Parliament several times, that is on 11 and 15 of April, 14 of May and 04 of June. As of today this draft resolution is being included into the agenda of 4th session of the Verkhovna Rada of Ukraine of the 7th convocation.

The Government would continue informing the Committee on any further progress of the execution of the Court's judgment at issue.
