INFORMATION

on the enforcement of the judgment of the European Court of Human Rights in case no. 26676/06 Manulin v. Russia (judgment of 11 April 2013, final on 11 July 2013)

## Violation:

In the judgment in case *Manulin v. Russia* the European Court of Human Rights found a violation by the Russian authorities of Article 3 of the Convention for the Protection of Human Rights and Fundamental Freedoms due to the improper conditions of K.V. Manulin's detention in the remand prison; Article 5 § 3 of the Convention – on account of excessively length of the applicant's detention under the court's judgments, which did not specify sufficient grounds for application of the restrictive measure.

### **Individual Measures:**

The payment was made in full and in due time on 30.08.2013 in roubles according to the exchange rate at the date of the payment (payment order no. 1375147 for the amount of RUB 266,327.40).

2. The criminal proceedings against K.V. Manulin were terminated, the applicant was released on 8 December 2005.

Due to the violation of the Convention the European Court awarded in favour of K.V. Manulin compensation for non-pecuniary damage, which was fully paid by the Russian authorities as noted above.

According to the Moscow City Court, the applicant or his representative did not submit any claims to the court after the European Court's judgment became final.

#### **General Measures:**

1. In accordance with the Regulation on the Representative of the Russian Federation at the European Court of Human Rights - Deputy Minister of Justice of the Russian Federation, approved by the Decree of the President of the Russian Federation no. 310 of 29 March 1998, the judgment of the European Court in case *Manulin v. Russia* was forwarded to the Constitutional Court of the Russian Federation and the competent state bodies (the Supreme Court, the Moscow City Court, the General Prosecutor's Office, the Ministry of the Interior of the Russian Federation, the Investigative Committee of the Russian Federation, the Federal Security Service of the Russian Federation, the Federal Drug Control Service of the Russian Federation) to take

into account in their practice and take the required general measures to prevent further violations found by the European Court.

The said competent state bodies forwarded a copy of the European Court's judgment to the lower courts, divisions and territorial bodies respectively.

2. The European Court's judgment in case *Manulin v. Russia* into Russian was published on the official web-site of the General Prosecutor's Office of the Russian Federation, as well as into the automated search system STRAS "Yurist" ("Lawyer").

Information about the European Court's judgment in case *Manulin v. Russia* into Russian was published in the information legal systems "Garant" and "Konsultant Plus". The text of the mentioned judgment into English was published in the information legal system "Konsultant Plus".

3. General measures aimed on providing persons' rights during their detention as well as ensuring appropriate detention conditions in remand prisons are taken within scope of enforcement of the pilot judgment of the European Court in case *Ananiev and Others v. Russia* as well as European Court judgments in *Klyakhin* and *Kalashnikov* groups of cases.
