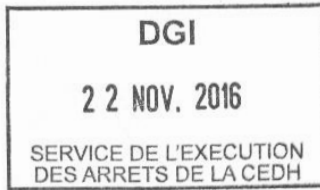

ADDITIONAL INFORMATION concerning the SUBMISSION to the Committee of Ministers dated 15 November 2016

Date of next examination: 6-8 December 2016
(CMCE-DH meeting 1273)

We would like to inform the Committee of Ministers that since our submission was sent on 15 November 2016, the following Russian cities/regions banned the Gay Parade marches and all LGBT rallies applied for by the activists of Moscow Pride and the Russian LGBT Human Rights Project GayRussia.Ru (*numbering in continuation of the Table at pages 2-3 of the Submission dated 15 November 2016*):

- 57. Abakan (Republic of Khakasiya);
- 58. Krasnoyarsk (Krasnoyarskiy Krai);
- 59. Kemerovo (Kemerovskaya Oblast);
- 60. Tomsk (Tomskaya Oblast);
- 61. Novosibirsk (Novosibirskaya Oblast);
- 62. Barnaul (Altayskiy Krai);
- 63. Gorno-Altaysk (Altai Republic);
- 64. Omsk (Omskaya Oblast).

Thus, as of today, just in 2016 the Gay Parade marches and all LGBT public assemblies were banned in **64 Russian cities located in 63 out of 85 constitutional regions**, in the absolute majority of cases on the basis of the Russian Federal law prohibiting so called propaganda of non-traditional sexual relations among minors.
