

**Re: Application No. 16071/90 – Savvas Kalli Hadjipanteli**

We are acting in the name and on behalf of the Applicants in the abovementioned Application brought before the European Court of Human Rights, in which the Grand Chamber issued a judgment in favour of the Applicants on 18.09.2009 (Case of Varnava and Others v. Turkey – Applications No. 16064/90, 16065/90, 16066/90, 16068/90, 16069/90, 16070/90, 16071/90, 16072/90 and 16073/90).

We wish to inform the Committee that the family of the missing Savvas Kalli Hadjipanteli have only recently been informed of, and provided with, the File Report prepared by the Turkish authorities concerning the alleged investigation into the circumstances surrounding his disappearance and subsequent death.

The Applicants hereby fully reserve their rights to comment on the contents of the said File Report in the next meeting of the Committee of Ministers (DH), currently scheduled for September 2017.

We would also like to take this opportunity to reiterate that, despite our repeated calls to date, Turkey has systematically denied and continues to deny the payment of the amounts
