**Dear Secretariat.**

The court order which was ruled on 29.10.2007 by Azerbaijan judicial system and similarly by EHCR on 30.06.2016 has not been enforced by Azerbaijan Government.I have many times formally asked all the relevant local Government agencies to implement these rulings but unfortunately,I have not received 142 square meter land in Azerbaijan.

Also the payment of 3,600 euros by Azerbaijan Government in accordance with EHCR ruling was not correctly implemented.Due to delay in payment I was debited 3583,67 euros.The difference was deducted as tax by the bank.However,according to EHCR regulations the payment in accordance with a ruling should be tax free.

Taking into account the above mentioned I am asking you to demand from Azerbaijan Government to implement the court rulings in regards to 142 square meter land and payment of the sum with interest which was deducted as a tax.
