Secretariat Memorandum prepared by the Directorate of Human Rights

The term of office of nine members of the European Commission of Human Rights in respect of France, Greece, Iceland, Ireland, Italy, Luxembourg, Sweden, Switzerland and Turkey will expire on 17 May 1981.

Under the terms of Article 21 of the European Convention for the Protection of Human Rights and Fundamental Freedoms, the Committee of Ministers is requested to elect the members of the Commission from the lists of names drawn up by the Bureau of the Consultative Assembly, each group representing the High Contracting Parties concerned in the Assembly presenting three candidates of which 2 at least are of its nationality.

# MR GEORGES TENEKIDES

Mr Georges TENEKIDES, son of the legal expert Tenekides, was born on 30 August 1910. A Doctor of Laws of the University of Paris (with a doctoral thesis on the individual in the international legal system, he was Professor of Public Law &t the University of Athens (1938-41), Professor of International Law at the University of Salonika (1941-46) and Professor, then Rector at the "Panteios" College of Political Science in Athens (1951-67). Having been dismissed by the Athens military regime, he was reinstated by the civilian government in September 1974 and appointed to the Sixth Committee (Legal) of the United Nations General Assembly. At the time of the April 1967 coup, he was summoned by his Paris colleagues, and since April 1968 he has been lecturing in international law and European organisations as Associate Professor at the Université de Droit, d'Economie et de Sciences Sociales de Paris (Paris II). In 1956 and 1963 he taught at The Hague Academy of International Law, where he ran the study and research centre in 1968. Elected corresponding member of the Bordeaux Académie des Sciences, Belles-Lettres et Arts. Honorary Doctor at the Universities of Lyon (1961) and Brussels (1969). Author of many publications on institutions and international relations, history, political science and law, including textbook on European organisations (Paris, "Les Cours de Droit" 1972, 566 + 143 p).

# MR EMIANUEL J ROUCOUNAS

Professor of International Law and Diplomatic History Faculty of Law, Athens University, Greace.

Born in 1933.

Studied law and interactional relations in Paris Lyons, the Fague. New York.

Professor Giuseppe Sperduti has been an active scholar for 40 years and is one of the most distinguised legal academics.

He has more than a handred publications to his name including articles, essays, mongraphs, courses of lectures in public international law (lectures, Milan 1958), private international law (course of lectures at the Academy of International Law, The Hague, 1977), international civil procedure (lectures, Pisa 1958), international organisations (introductory course, Rome 1972).

His commitment to research has not diminished with time, as is shown by the enclosed list of more than 40 works published during his first period of teaching in the Faculty of Rome from 1970 to the academic year 1977-78.

The effect that his research has had, can be shown by works dating b ack to 1938 ("Limiti della giurisdizione italiana in materia di sequestro conservativo e di provvedimenti cautelari in generale"), and 1944, ("Contributo alla teoria delle situazioni giuridiche soggettive"): the former led to the first ever provision in the Italian Code of Civil Procedure on the subject.

He also gave an impetus to studies on the individual in international law, one of the most serious problems of our time, beginning with a monograph on the subject in 1970 and a course of lectures at the Academy of International Law, The Hague, and continuing with a whole series of studies on fundamental rights and freedoms.

For the sake of brevity, two of his recent works on other subjects are mentioned: "La recevabilité des exceptions préliminaires de fond dans le procès international", in Mélanges Cassin, 1970, and Norme di applicazione necessaria e ordine pubblico, in Rivista di diritto internazionale privato e processuale, 1976. The first of these works led to an appropriate amendment of the Rules of Court of the International Court of Justice (Art. 67, New Rule of Court 1972). This was an important amendment because, up to then, the permanent Court of International Justice had always held that only standard objections were admissible as preliminary objections. The second work deals with the general theory of Private International Law. The idea of mandatory rules, which was introduced by Professor Sperduti 25 years ago, has been increasingly accepted by Italian and foreign theorists and may now be regarded as accepted jurisprudence.

His most recnet works point towards a revision of the very essence of international law. One of these is: "Il primato del diritto internazionale del sistema del diritto interno", in Rivista di diritto internazionale, 1978.
