Additional information to the Submission before the Committee of Ministers on the implementation of general measures in respect to the cases of Ţicu v. Romania (24575/10) and Predescu v. Romania (19696/10)

Considering the response of the National Administration of Penitentiaries (NAP) to APADOR-CH's FOI request<sup>1</sup> we add the following information:

The total number of detainees who received treatment for mental illness, in the period 2016-2019:

As the numbers show, in 2019 only there were 2225 detainees who received treatment while the total number of psychiatrics that are currently working in all the penitentiaries is 11.

The total number of patients in the psychiatric units in 2019 was **1713** while the total number of beds in all the psychiatric units is **149**. We obviously understand that the accommodation of patients is not done simultaneously, but even under these conditions we find the beds' number totally insufficient for the number of patients.

Moreover, the total number of the psychologists that are currently working in all the penitentiaries is 175<sup>2</sup>. It is indeed a better situation than the psychiatric assistance, but we have to keep in mind that the psychosocial service is responsible for all the detainees. Considering the information published by the National Administration of Penitentiaries, on 25.06.2019 the prison population amounted to 19083 detainees.<sup>3</sup> This clearly raises a question mark upon the quality of the psychological assistance.

Not least, in the Government's updated action plan from 2016 it was mentioned a draft of the general director of NAP' decision concerning the profiling of penitentiaries. According to this draft "prisoners with severe psychiatric conditions in compensation stages, who require only monitoring or find themselves in a period of stabilized medication, will be accommodated in the sections intended strictly for inmates with severe psychiatric conditions. The rooms in these sections will be organized similarly to infirmary chambers, with distinct functional circuits and beds on a single row. The aforementioned functional circuits entail separate arias, distinct from the common spaces intended for the remainder of prisoners. The placement in such rooms will be effected only at the indication of the unit's medical staff. Permanent supervision will be ensured through nurses; the medical centre will be set up in the proximity of the infirmary accommodation rooms. The treatment will be applied under strict medical supervision. Out of cell activities will be performed separately by persons with severe psychiatric conditions."

The Decision 704/2016 was adopted on 11<sup>th</sup> October 2016 and according to art. 3 (10): "The prisons-hospitals in which special sections for the detainees with serious mental

disorders, including those caused by alcohol or other psychoactive substances, are provided in annex no. 2. In all places of detention, infirmaries are established with stationary rooms and structural sections in which rooms are used for the accommodation and treatment of detainees with serious mental disorders, including those caused by alcohol or other psychoactive substances."

There is a substantial difference between the updated action plan (12<sup>th</sup> October 2016), the decision of the general director of NAP (11<sup>th</sup> October 2016) and the existing situation.

Both the action plan and the general director of NAP's decision mention special places for detainees with severe mental disorders. From APADOR-CH's <u>monitoring visits</u> in penitentiaries conducted starting with January this year, the organization couldn't identify this special places so far. Moreover, the updated action plan speaks about strict medical supervision in applying the treatment, which is impossible considering the lack of psychiatrists in most of the penitentiaries.

Regarding this issue, APADOR-CH appreciates the progress of the Government in organizing special rooms for the accommodation of detainees with mental disorders as it was mentioned in the recent information note. However, the progress is too slow compared to the amplitude of the problem. There are almost 3 years since the Government declared in the action plan this initiative and at the present moment none of the spaces are ready to use.

APADOR-CH reiterates the importance of the psychiatric and psychological assistance for the detainees while in prison and for their social reintegration and therefore recommends the Committee of Ministers to urge the state for solving the problem on long terms.
