## Dear Mr Pushkar,

With reference to your letter of 27 June 2019 regarding the letter of applicant Kolomiyets V.I. of 19 April 2019 writing on behalf of Kolomiyets V.V. (application no. 31207/13) please be informed of the following.

According to the information received from the State Bailiffs' Office, on 13 June 2019 the Ministry of Justice of Ukraine received Kolomiyets V.V. claim for payment of just satisfaction. Consequently, on 21 June 2019 UAH 12,213.36, the equivalent of EUR 400, i.e. one quarter of the total amount awarded to the Kolomiyets family, was paid to Kolomiyets V.V.

On 26 June 2019 the State bailiff issued a resolution on termination of the enforcement proceedings, considering that the judgment had been fully enforced.

The sum of just satisfaction was paid to Kolomiyets V.V. outside the time limit set in the resolution part of the judgment of 03 May 2018 in the case of Kovalenko and others v. Ukraine (application no. 42466/10 and 3 others), namely three months, given the fact that the applicant provided the State Bailiffs' Office with the relevant documents after the expiration of the abovementioned three months. Therefore, there are no grounds for calculation and payment of default interest.

In addition, the awarded to the Kolomiyets family amount of just satisfaction was equally divided between members of this family mentioned in the appended table to the judgment in the case of Kovalenko and others v. Ukraine (application no. 42466/10 and 3 others) and paid into their bank accounts. Namely, Kolomiyets V.I. was paid UAH 12,311.08, the equivalent of EUR 400, on 26 July 2018; Kolomiyets N.S. was paid UAH 12,311.08, the equivalent of EUR 400, on 28 August 2018; Kolomiyets S.V. was paid UAH 12,311.08, the equivalent of EUR 400, on 11 September 2018 and Kolomiyets V.V. was paid UAH 12,213.36, the equivalent of EUR 400, on 21 June 2019.
