## **Execution of Judgments of the European Court of Human Rights**

#### Action Plan on measures to be taken for implementation of the Court's judgments <u>in Merit/Svetlana Naumenko</u> groups of cases (application nos. 66561/01 and 41984/98, judgments final on 30/06/2004 and 30/03/2005, respectively)

#### CASE SUMMARY

These groups of cases concern mainly the excessive length of civil (*Svetlana Naumenko* group) and criminal (*Merit* group) proceedings and the lack of effective remedies in this respect (violations of Article 6§1 and Article 13 of the Convention).

Other violations found by the Court concern:

- the failure to enforce domestic court decision (violation of Article 6§1 and Article 1 of Protocol No. 1 to the Convention);
- the lack of a fair trial due to the application of the supervisory review procedure (violation of Article 6§1 of the Convention);
- the lack of relevant and sufficient grounds for the continued detention on remand of the applicants (violation of Article 5§3 in the *Burov* and *Kolesnikov* cases);
- the excessive length of restriction on the applicant's freedom of movement (violation of Article 2 of Protocol No. 4 in the *Zarochentsev* case).

#### **INDIVIDUAL MEASURES**

As regards payments of just satisfaction and information on criminal and civil proceedings against the applicants, the Government of Ukraine would like to provide all relevant information attached in *Annex I* and *Annex II*.

#### GENERAL MEASURES

From the very outset, it is worth noting that the Government of Ukraine understand the importance of ensuring steadfast political will, continuous political support at the highest level to resolve systematic problem at stake, as well as establishing an effective mechanism for the enforcement of domestic court judgments, including the provision of compensation for delays in the enforcement of judicial decisions.

Integrated solution of the issues at stake is crucial in order to gain the compliance of Ukraine's legal system with the European system of human rights protection. The above issue has the direct influence on the process of implementation of the European standards in the Ukrainian judicial system, as all such issues has a direct influence on the compatibility of the national legal system with European constitutional law.

The Government briefly recall the information on general measures which was provided in their previous action plan of 27 July 2018, so that the Committee could clearly distinguish the achievements and see the progress made.

So far, the Government have already noted information regarding:

- the efficiencies of the Strategy for Sustainable Development "Ukraine 2020";
- the preparation of the "Proposals for the Concept on the Solving the Problem of Excessive Length of Judicial Proceedings in Ukraine" (*copy of which is enclosed to this Action Plan*);
- elements within the framework of the on-going judicial reform in Ukraine which should reduce the length of proceedings;
- including the principle of reasonable length of proceedings envisaged in Article 129 of the Constitution of Ukraine;
- amendments to the Code of Civil Procedure establishing "cassation filters", a simplified
  procedure for the examination of minor civil disputes and labor disputes, mechanisms which
  would prevent inappropriate behavior of the parties.

## 1. As regards judicial reform

The judiciary, justice and related legal institutes were reformed in two stages: first stage – immediate renewal of legislation aiming to restore public trust in Ukrainian judiciary and related legal institutes; second stage – systemic changes in regulatory framework, including by introducing amendments to the Constitution of Ukraine, and comprehensive building of institutional capacities.

For today, judicial reform is ongoing in Ukraine. At the same time, there are a number of issues which require urgent resolve, among them are interfering in the administration of justice by judges, the establishment of new courts, providing the unified rate of judicial remuneration and adequate judicial protective guarantees. It is also requires considerable effort to address the "personal component" of judicial reform, which is to modernise the judicial corps. The judges of the local and appellate courts pass a qualification assessment, which is a constitutional requirement, based on the criteria of competence, integrity and professional ethics.

Moreover, half of the total amount of judges has passed the qualification assessment. At the same time, over 2000 judges were dismissed, which significantly affected the courts' staff system and ability to ensure a fair hearing within a reasonable time. At present time, 14 courts do not administer justice due to the lack of judges or the authority of judges; in 154 courts the number of judges administering justice is less than 60 percent of the full-time staff. The issue of significant difference in the remuneration of judges who have not yet passed the qualification assessment and those already assessed. This is caused by the length of the qualification evaluation process and the simultaneous holding of competitions before the Supreme Court, the Supreme Anticorruption Court and the High Court on Intellectual Property, as well as the current selection of candidates for the position of judge for training at the National School of Judges of Ukraine. The above can negatively influence on the duration of litigation and restrict the rights of individuals to access to justice.

By Decree of the President of Ukraine No. 421 of 21 June 2019, the Commission on Legal Reform was established as an advisory body to the President of Ukraine. In this regard, the Judicial Reform Council and the Constitutional Commission were liquidated. The Decree of the President of Ukraine No. 584/2019 of 7 August 2019 approved the Regulations on the Commission on Legal Reform and its Members which included two members of the High Council of Justice. The Commission on Legal Reform (hereinafter - the Commission) is an advisory body to the President of Ukraine and should base its activity on the principles of rule of law, openness and transparency, professionalism and

integrity, self-government and independence in decision-making. The main task of the Commission is to promote the development of the legal system of Ukraine on basis of the constitutional principles of the rule of law, the priority of human rights and freedoms, taking into account Ukraine's international commitments. On 20 August 2019, members of the High Council of Justice submitted to the Working Group on the Development of Legislation on the Organisation of the Judiciary and the Administration of Justice of the Commission their proposals regarding improvement of the work of justice system.

Definitely, there is a close link between ensuring of independence, impartiality and fairness of judges and solving the problem of lengthy proceedings. In this regard, the Government of Ukraine have adopted the following key legislative acts.

<u>The Law of Ukraine "On Ensuring the Right to a Fair Trial".</u> It envisaged the rights of people regarding guarantees of equality before the law and the court, publicity, openness of the trial, binding decision of the court; the procedure of appointing judges became more transparent; the procedures of judges election, their appointment and transfer to other courts, which are to be held only on a competitive basis, were unified. The law also introduced a system of judges' professional evaluation.

<u>The Law of Ukraine "On Amendments to the Constitution of Ukraine (on Chapter "Justice")"</u> made it possible to restart the judicial system and change its structure. Constitutional changes were aimed at implementing full-scale judicial reform and updating the judiciary in accordance with public expectations and in accordance with European standards, restoring public confidence in the judiciary, as well as ensuring the proper functioning of the prosecutor's office, advocacy and judicial enforcement system. Amendments to the Constitution of Ukraine have been commended by the Venice Commission, which described in its Final Document CDL-AD(2015)027<sup>1</sup> the amendments as "very positive and well-designed and deserve to be fully endorsed".

<u>The Law of Ukraine "On Enforcement Proceeding".</u> The Law aimed at ensuring the quality and speedy execution of judgments and decisions of other national authorities in accordance with European standards – the time limits for executive actions were optimised; new procedure of appeal the decisions or failure to act of executive officers; hands-off procedure of execution of decisions and possibility of disposition of the arrested property by sale with the help of public electronic sale were introduced.

The Law of Ukraine "On the Bodies and Persons who carry out the Enforcement of Judicial Decisions and Decisions of Other Agencies". A key novelty of the new legislation on the reform of the executive system is the introduction of a dual system of enforcement by modernising the bailiffs' service and introducing new institute of private bailiffs.

<u>The Law of Ukraine "On the High Council of Justice".</u> The Law envisages the status, competences, and standards of organisation of a new body of judicial administration – the High Council of Justice. The main task of this body is to ensure the independence of the judiciary on the basis of responsibility and accountability to the public.

The Government have already mentioned that the process of increasing independence of the judiciary and streamlining competences of different jurisdictions was ongoing. This process have included many elements, *inter alia*, improvement in use of information systems (IS) for greater delivery of e-justice services. As a result of comprehensive cooperation of the relevant authorities, the analysis of the legislation, current administrative practice and available technical mechanisms, as well as the engagement of expertise of the international experts, the following developments of the "System of E-Services" are now provided for the parties to the proceedings:

- Possibility of on-line payment of the judicial fees (on the official web-page of the Judiciary of Ukraine);
- acquirance of information about the stages of judicial proceedings (official web-page of the Judiciary of Ukraine provides for the possibility for users of the portal to review/search/print information concerning the stages of examination of cases);
- acquirance of information from the Unified State Register of Court Decisions. The registry is an automated system for collecting, storing, protecting, registering, searching and providing electronic copies of court decisions;
- submitting the procedural documents to the parties by e-mail. Thus, the parties have the
  possibility to receive procedural documents in electronic form in addition to the paper
  documents.

As regards judicial reform, at present the corpus of judges is under the process of reformation. By formation of the new corpus of judges the Government aimed at establishing the institute of the judges' secondment to the other courts for regulation of their workload.

The Head of the Council of Europe Office in Ukraine, Morten Enberg, also highlighted the positive developments following the judicial reform, noting that the introduction of a mechanism to counteract the length of court proceedings is an important step for today<sup>2</sup>.

During February-May 2019, the United States Agency's for International Development (USAID) Justice Sector Reform Program named "New Justice Sector" conducted three surveys of justice sector professionals, lawyers, and jurors on the outcomes of the judicial reform and compliance with the rule of law principle by the courts. As to results of the research, more than 90% of the jurors admitted that the court decisions as well-founded, clear-cut, made under the law, fair and that the length of the court hearings is admissible in a majority of cases<sup>3</sup>.

As regards establishment of a mechanism of fair workload distribution between the judges, on 2 March 2018 the Council of Judges of Ukraine adopted decision No. 17<sup>4</sup> On Bringing in line the Statute on Automatic Document Management System with point 9§2 of the Final Provisions of Chapter VII of Transitional Provisions of the Law of Ukraine "On Amendments to the Code of Commercial Procedure of Ukraine, the Code of Civil Procedure of Ukraine, the Code of Administrative Justice of Ukraine and other legislative acts" dated 3 October 2017, namely in part of the procedure for determining a judge or a panel of judges to consider a specific case.

Moreover, in order to comply with the requirements of the Statute on Automatic Document Management System in courts, courts of first instance have developed the Principles for Use of the Automatic Document Management System to ensure that the automatic system operates in such a way that it complies with the fundamental principles of the Committee of Ministers of the Council of Europe in accordance with principle I(2)(e) of the Recommendation No. (94) 12 "Independence, efficiency and role of judges", which states that the distribution of judicial cases between judges should not be affected by the intentions of one of the parties to the case or any person who is interested in the outcome of the case.<sup>5</sup>

As regards introduction of mechanisms to reduce the number of abuse of procedural rights, it is worth noting that the recent practice of the Supreme Court has been significantly changed. It demonstrates that there is a coherent approach in counter abuse of procedural rights by imposing fines on parties and their representatives, returning and leaving applications and complaints without consideration and by appealing to the Qualification and Disciplinary Commission of Advocacy<sup>6</sup>. Current approach aimed at discipline the parties in the trial and obligates them to exercise their procedural rights in good faith and assist the court in the performance of its functions<sup>7</sup>.

As to the enhancement of the means of alternative dispute resolution, including mediation in Ukraine in order to prevent of the overloading of the judges, it should be noted the extension of the practice of alternative dispute resolutions, which is proved by domestic court practice<sup>8</sup>. The implementation of the mediation processed as a method of the dispute resolutions is an efficient mechanism for unloading the courts. The Presidential Decree No. 276/2015 of 20 May 2015 "On Strategy of the Reform of Judiciary and Related Legal Institutions for the period of 2015-2020" which is currently in force in Ukraine foresees the expansion of ways of alternative dispute resolution, in particular, through the implementation of the mediation in the court system. Moreover, the Draft Law "On Mediation" No. 3665 of 17 December 2015 is currently pending before the Parliament of Ukraine. The law envisages procedural guarantees of mediators, their legal status and order of conduct mediation.

## 1.1 As regards legislation

In the expert analysis of the Code of Criminal Procedure of Ukraine (**the "CCP**") conducted by international experts within the Council of Europe Project "Continuing Support to the Criminal Justice Reform in Ukraine" concerning compliance of the CCP with requirements of Article 6§1 of the Convention on the length of criminal proceedings highlighted the following positive impact of the judicial reform and new draft of the CCP:

presence of the criminal law provisions with the definition of the "urgency" of carrying out the
procedural actions, which ensures the effective conduct within a reasonable time and clearly
regulates the time limits for conduct of procedural actions by the officers of law enforcement
bodies;

- envisaging in Article 114 of the right of the investigating judge and the court to "set up the strict procedural time limits within the period of time prescribed in the Code" to "ensure that the parties of the criminal proceeding meet the requirements of a reasonable time".

In light of the analysis of the other Council of Europe Member States' good experience and taking into account the Recommendation Rec(2004)6 (para. 21) of the Committee of Ministers to the Member States "On Improvement of Domestic Remedies", the time-limit of pre-trial investigation envisaged in domestic procedural law were reduced due to the amendments to Articles 219 and 284 of the CCP. At present, following the above amendments, it prescribes the <u>pre-trial investigation period of three</u> <u>months for medium-gravity crimes</u> and six months for investigation of especially grave crimes which are calculated from the moment of entering the information regarding criminal offence to the Unified Register of Pre-Trial Investigations. The Government believe that the newly-established time-limits will bring forward the effective and proper conduct of investigation by national authorities.

As to legislative amendments regarding the beginning of expiration of time limits of pre-trial investigation, it should be noted that the previous wording of the CCP envisaged the pre-trial investigation period of no more than 2, 6 and 12 months depending on the category of crimes respectively, from the date of notice of suspicion. As of today, pre-trial investigation period is calculated from the date of entering the data on the event to the Unified Register of Pre-Trial Investigations and is considered as completed on the date of transferring the bill of indictment to the court.

The above changes steamed from frequent occurrences of delays during investigation process in the national administrative practice due to the authorities' failure to identify the suspects. As a result, investigation was *de facto* being conducted, but there were no legitimate grounds for registration of its beginning in the Unified Register of Pre-Trial Investigations. Thus, it appeared to be impossible to establish the *de facto* beginning of the pre-trial investigation period.

Subsequently, the relevant authorities have provided analysis of the national administrative practice, as well as peculiarities of functioning of domestic judicial system and available legislative mechanisms of other EU countries, national legislation was changed in the above manner.

Another problematical issue in national practice which was detected by the practicing lawyers is the disproportionality of rights of the parties during the process. The restricted competence of the investigators and prosecutors in some cases can influence on the length of the proceeding because of the lack of procedural rights to initiate some of the investigative actions. The defense lawyers can abuse their rights which cause the delay of the investigation. National administrative practice demonstrates a plenty of cases of such abuses. In this regard, the newly elected Government initiated the amendments to the national procedural laws with the aim to extend the range of powers of the investigative officers and prosecutors. The above demonstrates the Government's continuing support and the presence of political will to resolve the issues in stake, despite the unstable political situation and change of power due to presidential and governmental elections in the country.

At present, the Draft Law No. 9044<sup>9</sup> "On Improving the Procedure for Compensation of Damage Caused to an Individual by Law Enforcement Bodies or a Court in accordance with the European

Court Case-Law" is pending before the Parliament of Ukraine. This Draft Law envisages the amendments to the Law of Ukraine "On the Procedure for Compensation of Damage Caused to Persons by Illegal Actions of the Officers of Investigative Bodies, Prosecutor's Office and Courts" and to the Code of Civil Procedure of Ukraine, which will prescribe an obligation for compensation for the unlawful detention, breach of reasonable time of pre-trial investigation and trial in criminal proceedings. The Draft Law aims at ensuring the compliance of the national legislation with the Court's standards.

Needless to mention that the National Police of Ukraine in cooperation with the Parliament of Ukraine Committee on Legislative Support of Law Enforcement Bodies developed the Draft Law of Ukraine "On Amendments to Some Legislative Acts of Ukraine on Simplifying Pre-Trial Investigation", No. 7279-d dated 19 April 2018. The Law was adopted by the Parliament of Ukraine on 22 November 2018. Adoption of this law and introduction of a simplified procedure for the investigation of a number of non-grave crimes will allow unloading of the investigative bodies and will provide them with a possibility to concentrate the activity on the investigation of grave and especially grave crimes. Moreover, the investigators will have a possibility to conduct pre-trial investigation in form of "enquiry". The above is aimed to minimise risks that lead to lengthy pre-trial proceedings.

As to the Draft Law on Amendments to the Civil Code of Ukraine "On Improvement of Legal Regulation of Compensation for Damage Caused by the Court and the Officers of Law Investigative Bodies and Prosecutor's Office" No. 7513, it was withdrawn due to change of power and start of work of the new parliamentary session. Nevertheless, the Government believe that this draft law will be soon revised and considered by the Parliament.

Moreover, during the comprehensive analysis of the grounds for lengthy pre-trial investigation, the following shortcomings of the current criminal procedural legislation and work conduct by the Prosecutor's Office of Ukraine units and courts, namely:

- absence of the CCP provisions determining the period of time for prosecutor's approve a notice of suspicion. In this regard, due to the administrative practice prosecutors may review suspicion reports for the period of more than 10 days;
- lack of the necessary number of supervisors of pre-trial proceedings. According to the overload, the latter are not able to review draft suspicion reports within the reasonable time and to reconcile indictments;
- the presence of requirement to deliver the potential suspects, as well as other participants to the criminal proceeding for hand over the notice of suspicion;
- lack of procedural independence of supervisors of pre-trial proceedings and the presence of the requirement to agree with the head of the local prosecutor's office the establishment of notification of suspicion or approval of the indictment;
- breach of reasonable time requirements when making a decision on appointment of forensic examination or on application of security measures in criminal proceedings at the request of the investigating judge or a court following the request of the party to the criminal proceeding.

In order to overcome the above shortcomings for breach of the reasonable period of pre-trial investigation, relevant competent authorities have developed the following draft laws:

- Draft Law No. 8249 of 6 April 2018 "On Amendments to Certain Legislative Acts of Ukraine on Improvement of the Forensic Examination Procedure", which ensures prosecution and defense with the right to call for the forensic experts;
- Draft Law No. 8336 of 4 May 2018 "On Amendments to Certain Legislative Acts of Ukraine on Strengthening the Guarantees of Independence of the Forensic Expert and the Proper Conduct of Forensic Examination";
- Draft Law No. 1009 of 29 August 2019 "On Amendments to Certain Legislative Acts of Ukraine on Improvement of the Provisions of Criminal Procedural Legislation", which prescribes the expanding of the subjects who may conduct forensic expertise by private experts;
- Draft Law No. 8116 of 14 March 2018 "On Amendments to Certain Laws of Ukraine on the Grounds for Conduct Forensic Expertise";
- Draft Law No. 8112 of 13 March 2018 "On Amendments to the Code of Criminal Procedure of Ukraine regarding the Procedure of Expertise Assignment".

The Government would like to provide some examples of domestic court practice which confirms the compliance with the time limits prescribed in procedural law, in particular, through the widespread use of fast track proceeding while considering the cases.

On 17 July 2019 the Dykansky District Court of Poltava Region initiated the proceeding in the case concerned the recognition of a person as deprived of the right to use the premises. As a result of consideration of the case, on 9 August 2019 the trial court decided to satisfy the person's claim. Thus, the dispute was resolved within one month, and the plaintiff's right to use his premises was renewed.<sup>10</sup>

On 1 March 2019 the Kyiv Town-District Court of Kharkiv by initiated a hearing, applying the fast-track proceeding, on a person's claim against a state-owned enterprise for recovery of not paid salary and schedule for a hearing on 27 March 2019. The court hearing was held on an appointed date. The applicant's claim was satisfied and the whole amount of salary (UAH 27 206) was recovered from the state enterprise in favor of the applicant.<sup>11</sup>

To sum up, according to the Supreme Court position, the mechanism of fast track proceeding is actively functioning and due to the tendency, the number of cases considered within simplified procedure will increase in the nearest future, enabling the participants in the court proceedings to restore and protect their violated rights and interests promptly and within a reasonable time.

The resolution of a lengthy of the proceeding and the insurance of compliance with the reasonable time requirement in civil procedure is also facilitated by the implementation of the rules of Chapter 4 Section 3 of the Code of Civil Procedure which regulate the settlement of a dispute with the judge's assistance following the consent of the parties and prior to the commencement of the case on merits, which is *de jure* submitted to the court. Thus, according to the State Judicial Administration, in 2018 about 95 cases were considered with the judge's assistant. The above mechanism is a novelty in the civil procedure, and therefore to increase the frequency of its application, the Government conduct an extensive awareness-raising campaign with the aim to inform all interested parties of the functioning of the mechanism.

In accordance with the new Code of Administrative Justice of Ukraine (Section 3), which entered in legal force on 15 December 2017, so called "procedural novel" has been appeared in the Ukrainian courts' practice. For the first time, the Code envisaged a new law category such as "typical case" and "model case", as well as peculiarities of proceedings in these cases. Consideration of a typical case is possible only after examination of a model case under the rules of simplified proceedings and delivering of a relevant judicial decision, which aimed at reducing the length of proceedings. The main elements of a model case are:

- one and the same state authority (its separate division);
- the administrative dispute aroused on the similar grounds;
- the matter of the dispute is envisaged by the same rule of law;

• the plaintiffs submitted similar complaints.

In the event, when cases which are meet the mentioned requirements of a model case are pending before one or more administrative courts, and the adoption of a model decision became viable, such administrative courts shall file a relevant submission to the Supreme Court, as a court of first instance, to consider one of these cases as a model.

The court's proceedings should be opened within 10 days from the date of receipt of the case files by a panel of 5 judges of the Supreme Court. The delivered model decision can be appealed to the Grand Chamber of the Supreme Court.

As of today, the Cassation Administrative Court within the Supreme Court examined about 13 model cases; among them in 4 cases the applicants' claims were fully satisfied. Functioning of the "model case" institute ensures the coherence of judicial practice and forwards the resolve of the problem of excessive length of court proceedings and the workload of judges of administrative courts.

In this regard please be advised with some judicial practice concerning examination of the model cases by the Supreme Court.

On 26 March 2018 the Supreme Court considered the model case<sup>12</sup> concerning the recalculation of the retirement pension of the Ministry of Internal Affairs of Ukraine taking into account the collateral security of the police officers. The matter of the dispute was that the plaintiff, retired officer, who, from 1 January 2015, was granted a retirement pension and the defendant, the local agency of Pension Fund of Ukraine, did not transfer the pension according to the collateral security of the police officers. The reason of a failure to transfer and pay the pension was the lack of funds in the State Budget. The Supreme Court stated that due to domestic law the fluctuation of the collateral security of the police officers is identical to the relevant components of the awarded retire pension to the former police officers, but larger in its rate, that's why it is an undoubted reason for recomputation of the plaintiff's pension as a former police officer on the basis of the Cabinet of Ministers of Ukraine Decree of 11 November 2015, No. 988, "On the Collateral Security of the National Police's Officers", which came into force on 2 December 2015. In its decision the Supreme Court also noted that the defendant's argument about the lack of funds for recalculation of pension violates the right to peaceful possession of his property, guaranteed by Article 1 of the Protocol No. 1 to the Convention. Thus, the court referred to the European Court conclusions in the case of "Kechko v. Ukraine" and found that the authorities couldn't argue that the lack of funds is a reason for the failure to fulfill their obligations. Thus, the local agency of Pension Fund of Ukraine was obliged to recalculate and pay the pension to the plaintiff.

## 2. <u>As regards cooperation activities with the Council of Europe</u>

The Government of Ukraine highly appreciate the contribution of the Council of Europe institutions in the development of an effective system of justice in Ukraine. The Government take into account and adhere to all Recommendations of the Committee of Ministers.

Recommendation Rec (2004) 6 (para 24) of the Committee of Ministers to the Member States "On Improving Domestic Remedies" provides for the Council's of Europe assistance to Member States in setting up effective remedies. In particular, in the form of reports on the findings in the result of analysis of the existing national remedies prepared by expert consultants with the aim at improving the efficiency of these remedies.

Thus, with the assistance of this mechanism, Ukraine have enlisted the expert support of the Council of Europe Office in Ukraine. In 2018 it was conducted a study with the aim to determine the level of acceptance and the assessment by representatives of the professional community of the preventive and compensatory remedies against the excessive length of judicial proceedings available in other Member States of the Council of Europe, in the context of possibility of their implementation in Ukraine. The draft Report<sup>13</sup> was presented during the expert discussion on the topic: "Effective remedies against the excessive length of proceedings: the implementation of the Court in "*Svitlana Naumenko v. Ukraine*" and "*Merit v. Ukraine*" groups of cases, which was held by the Supreme Court and the Ministry of Justice of Ukraine together with the Council of Europe Project "Supporting Ukraine in Execution of Judgments of the European Court of Human Rights". The outcomes of the above report were taken into account, *i.e.*, by judges in their work.

In addition, on 13 December 2018, a round table on duration of civil proceedings, on topic "An Analysis of the Code of Civil Procedureof Ukraine based on the European Court of Human Rights case-law" held in Kyiv. The event was organised by the working group established on the basis of the Supreme Court which consists of its judges and the Council of Europe's project "Supporting the Implementation of Judicial Reform in Ukraine". The aim of the event was to discuss the new civil procedure legislation of Ukraine and its impact on the length of court proceedings, to present the experience of Council of Europe member states in implementing mechanisms to overcome the lengthy of the proceedings in order to comply with the decisions of the European Court, as well as to

exchange experience and ideas for successful implementation of the new Procedural Codes of Ukraine to ensure a reasonable duration of civil proceedings in Ukraine<sup>14</sup>.

On 14 February 2019, the first meeting of the Steering Committee of the Council of Europe Project "Supporting Ukraine in execution of judgments of the European Court of Human Rights" took place in Kyiv. The aim of the meeting was to discuss the results of the Project in 2018, as well as to exchange opinions on priorities and plans for 2019.

On 18 February 2019, the Project, jointly with the Ministry of Justice of Ukraine, organised a conference "The Ministry of Justice of Ukraine and International Partners - implementing changes together! Results of 2018"<sup>15</sup>. During the conference, the Ministry of Justice of Ukraine, jointly with international technical assistance projects, reported on the results achieved in the justice sector reform in 2018 and discussed the priority areas of co-operation in 2019. The Project actively supported the panel discussion dedicated to the non-enforcement of national judgments in Ukraine, which is a biggest problem of the Ukrainian justice sector.

On 22 February 2019, the Project, jointly with the Supreme Court, organised a round table "Enforcement of Domestic Courts' Judgments: Current Issues and Possible Solutions". The round table aimed at discussing current issues with regard to enforcement of judgments of national courts, and at developing the relevant solutions.

On 24 June 2019 the Supreme Court and the Council of Europe projects "Supporting Ukraine in Execution of Judgments of the European Court of Human Rights" and "Continued Support to the Criminal Justice Reform in Ukraine" organised a round table entitled "Ukrainian procedural law and the problem of compliance with reasonable time in accordance with the requirements of Article 6§1 of the European Convention on Human Rights". The following questions were discussed:

- \_ general measures, taken to comply with the requirements of the Court's findings as regards the reasonable length of proceedings, in particular the execution of judgments in "Svitlana Naumenko v. Ukraine" and "Merit v. Ukraine" groups of cases;
- compliance of the provisions of the CCP with the requirements of Article 6§1 of the Convention;
- draft analysis of the impact on the length of the court proceedings due to the Code of Civil Procedure of Ukraine, the Code of Commercial Procedure of Ukraine, and the Code of Administrative Justice.

## STATE OF EXECUTION

The Government of Ukraine believe that they have fully examined the experience of other countries, Members of the Council of Europe, who were facing similar problems in order to adopt a comprehensive approach to this difficult issue.

From the very outset, it is worth noting that the Government of Ukraine understand the importance of resolving the problem in stake and its complexity, as well as the fact that Ukraine is not the only negative example of this phenomenon in Europe.

Indeed, the excessive length of proceedings is such a complex phenomenon that affected almost all the countries of the Council of Europe. The Government of Ukraine continue to study other member states' of the Council of Europe experience in solving this problem.

The Government of Ukraine believe they show due diligence in fulfilment of obligations arising from the above judgments and will inform the Committee about further developments and measures taken.
