Resolution CM/Res(2019)14 on the European Pharmacopoeia budget for 2020-2021

(Adopted by the Committee of Ministers on 21 November 2019 at the 1361st (Budget) meeting of the Ministers' Deputies)

The Committee of Ministers, under the terms of Article 16 of the Statute of the Council of Europe and in its composition restricted to the representatives of the States Parties to the Convention on the Elaboration of a European Pharmacopeia,¹

Having regard to Articles 3, 7, 8, 9, 15, 17, 18, 19, 21 and 23 of the Financial Regulations;

Having regard to Resolution CM/Res(2019)13 of 21 November 2019 fixing the scale of contributions of member States to the budget of the European Pharmacopoeia with effect from 1 January 2020;

Having regard to Article 5, paragraph 1 of Resolution Res(91)18 of 17 June 1991, setting up within the framework of the budget of the European Pharmacopoeia a subsidiary budget for the Biological Substances Standardisation Programme;

Having regard to the accession of the European Commission to the Convention on the Elaboration of a European Pharmacopoeia on 21 June 1994;

Having regard to paragraph 5 of Resolution Res(97)48 on the European Pharmacopoeia – 1998 budget of 11 December 1997, setting up within the framework of the budget of the European Pharmacopoeia a subsidiary budget – Development, Research and Multimedia;

Having regard to the draft Programme and budget for 2020-2021 submitted by the Secretary General (documents CM(2019)130, CM(2019)130-corr and CM(2019)130-corr2);

Having regard to the Budget Committee's report (document CM(2019)155),

Resolves as follows:

1. The European Pharmacopoeia Programme for 2020-2021 is hereby approved.

2. The European Pharmacopoeia budget for 2020 with expenditure and receipts totalling €107 782 100 according to Table A appended hereto is hereby approved.

3. The total of the budget of receipts shall be a function of actual receipts and the budgets of expenditure and receipts adjusted accordingly in the course of the financial year.

4. Approval is hereby given to the apportionment, among the States Parties to the Convention, of the contributions for 2020, totalling €2 847 100 according to Table B appended hereto.

¹ States concerned: Austria, Belgium, Bosnia and Herzegovina, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, Republic of Moldova, Montenegro, Netherlands, North Macedonia, Norway, Poland, Portugal, Romania, Serbia, Slovak Republic, Slovenia, Spain, Sweden, Switzerland, Turkey, Ukraine and United Kingdom.

5. In the event of there being a credit balance on the budget of European Pharmacopoeia at the end of 2019, the budgets of receipts and of expenditure of the budget for 2020 shall each be adjusted by an amount equal to the 2019 credit balance by means of its transfer to the budget for 2020.

6. Approval is hereby given to the European Pharmacopoeia investment projects plan for 2020, as well as for 2021 on a provisional basis, according to Table C appended hereto.

7. The European Pharmacopoeia budget for 2021 according to Table A appended hereto is hereby approved on a provisional basis.
