Resolution CM/Res(2019)16 on the Enlarged Partial Agreement on the Council of Europe Development Bank's budget for 2020-2021

(Adopted by the Committee of Ministers on 21 November 2019 at the 1361st (Budget) meeting of the Ministers' Deputies)

The Committee of Ministers, under the terms of Article 16 of the Statute of the Council of Europe, and in its composition restricted to the representatives of the States members of the Enlarged Partial Agreement on the Council of Europe Development Bank,¹

Having regard to Resolution Res(56)9 on the adoption of the Articles of Agreement of the Council of Europe Resettlement Fund for National Refugees and Over-Population in Europe and to Resolution Res(93)22;

Having regard to the Articles of Agreement of the Council of Europe Development Bank which entered into force on 18 March 1997;

Having regard to Articles 19, 21 and 23 of the Financial Regulations;

Having regard to Resolution CM/Res(2019)15 of 21 November 2019, fixing the scale of contributions of member States to the Enlarged Partial Agreement on the Council of Europe Development Bank budget with effect from 1 January 2020;

Having regard to the draft Programme and budget for 2020-2021 submitted by the Secretary General (documents CM(2019)130, CM(2019)130-corr and CM(2019)130-corr2);

Having regard to the Budget Committee's report (document CM(2019)155),

Resolves as follows:

1. The Council of Europe Development Bank's Programme for 2020-2021 is hereby approved.

2. The Council of Europe Development Bank's budget for 2020 with expenditure and receipts totalling €1 464 400 according to Table A appended hereto is hereby approved.

3. Approval is hereby given to the apportionment, among the States members of the Enlarged Partial Agreement on the Council of Europe Development Bank, of the contributions for 2020, totalling €950 000 according to Table B appended hereto.

4. The total of the budget of receipts shall be a function of actual receipts and adjusted accordingly in the course of the financial year.

5. The Council of Europe Development Bank's budget for 2021 according to Table A appended hereto is hereby approved on a provisional basis.
