This conference, jointly organised by the British Museum and the Council of Europe, is the first in a series of international conferences and colloquys to be held on the subject of the Bronze Age in different areas of Europe.

These conferences and colloquys form part of the awareness-raising campaign of the Council of Europe on the subject of "The Bronze Age - the first golden age of Europe". The campaign, which includes various activities on the national level, is being launched on 20 September at a press conference in Bratislava and with an opening exhibition in Budapest on the "Treasures of Bronze Age Hungary". The closing conference will be held at Forli (Italy) on 8-14 September 1996.

This campaign is part of the European Plan for Archaeology, initially proposed in Resolution no.1 of the 3rd European Conference of Ministers responsible for the Cultural Heritage at the time of the opening for signature in Malta in 1992 of the European Convention for the Protection of the Archaeological Heritage (revised). The European Plan has been conceived in order to reinforce the Malta Convention through developing certain of its aspects on the scientific level as well as encouraging public interest in the protection of the archaeological heritage.
