# Addendum to the Action Plan of 12/10/2020

With reference to the individual measures in the Nisiotis group of cases the Greek Government would like to provide the following clarifications:

A) All cases for which the Committee of Ministers considered that all necessary individual measures had been taken, namely the cases examined up to its 1324<sup>th</sup> meeting (September 2018), should be closed.

B) As regards the cases for which the Committee of Ministers at its September 2018<sup>1</sup> Meeting asked for information about the current situation of the applicants<sup>2</sup> it is noted:

In the cases Cela and Others and Kordas all applicants have been released.

In the cases Zournatzidis and Others, Singh and Others and Igbo and Others all applicants have been released but for

- a) Barjami Xhafer (Zournatzidis and Others)
- b) Mpatas Alexandros (Singh and Others)
- c) Iamail Gur and Ugyr Kahraman (Igbo and Others)

The Government will provide updated information on the current status of the above applicants.

C) As regards the cases which were classified as repetitive cases of the group after the Committee's last examination<sup>3</sup>, namely Pilalis and Others, Abdo and Others, Pekov and Andreeva and Marouggas, it is noted that all applicants have been released.

In view of the above mentioned the Greek Government respectfully propose to the Committee of Ministers the closure of all the repetitive cases where no individual measures are pending apart from the leading case (Nisiotis) and the cases Zournatzidis and Others, Singh and Others and Igbo and Others (see Annex).
