2. Signatures and Ratifications

Maldives ratified the Convention on Mutual Administrative Assistance in Tax Matters as amended by the 2010 Protocol (ETS No. 127), 20 September.

Hungary signed the Council of Europe Convention on Offences relating to Cultural Property (CETS No. 221), 5 October.

Germany ratified the Protocol amending the Convention for the Protection of Individuals with regard to Automatic Processing of Personal Data (CETS No. 223), 5 October.

3. Voluntary contributions

I would like to thank our donors for their support to our work and mention the recent voluntary contributions which I have had the pleasure to sign².

Norway

The Government of Norway has made a voluntary contribution of NOK 6,500,000 (approximately €643,668) to reduce the European Court of Human Rights' backlog of well-founded cases.

European Union

The European Union has made a voluntary contribution of €4,950,000 to the Joint Programme "Supporting the Effective Implementation of Turkish Constitutional Court Judgments in the field of Fundamental Rights". Co-funding from the Council of Europe Ordinary Budget to this Joint Programme amounts to €550.000.

The European Union has also contributed €500,000 to the Joint Programme "Co-operation on the implementation of the Russian Federation National Action Strategy for Women (2017-2022): Applying best practices". Co-funding from the Council of Europe Ordinary Budget to this Joint Programme amounts to €56,000.

United States of America

The Government of the United States of America has made a voluntary contribution of USD 1,505,999.60 (approximately €1,288,810) to support the Council of Europe action against cybercrime.

Australia

Australia (City of Salisbury) has pledged an annual voluntary contribution of €5,000 to the Intercultural Cities Programme.
