RE: Submission under Rule 9.1 on the payment of the just satisfaction in the case  
*N Applications nos. 23778/21 and 32 others – see appended list - "CASE OF CHIBYSHEV  
AND OTHERS v. RUSSIA"*

Dear Sir/Madam

I am the legal representative of the applicant **Sergey Viktorovich DRUCHEK** from the case *N Applications nos. 23778/21 and 32 others – see appended list - "CASE OF CHIBYSHEV AND OTHERS v. RUSSIA"*. On 4 July 2024, the ECHR adopted a decision on this case, which entered into force on the same day. The ECHR awarded the applicant **Sergey Viktorovich DRUCHEK** compensation in the amount of 4,000 euros. The deadline for payment of compensation is October 4, 2024.

The applicant sent information about his bank account to the Prosecutor General's Office of the Russian Federation. On 29.07.2024, the Prosecutor General's Office of the Russian Federation replied to the applicant that, in accordance with paragraph 1 of Article 7 of Federal Law No. 183-FZ of 11.06.2022 "On Amending Certain Legislative Acts of the Russian Federation and Invalidating Certain Provisions of Legislative Acts of the Russian Federation", the rulings of the European Court of Human Rights, which entered into force after 15.03.2022, did not are subject to execution in the Russian Federation (Attachment 1).

The applicant does not agree with the position of the Prosecutor General's Office of the Russian Federation. He notes that the facts giving rise to the alleged violations of the Convention took place before September 16, 2022, the date when the Russian Federation ceased to be a party to the Convention. Thus, the European Court has decided that it has jurisdiction to consider the present complaints (see *Fedotova and Others v. Russia* [GC], no. 40792/10 and 2 others, §§ 68-73, January 17, 2023).

For this reason, the applicant asks the Committee of Ministers to indicate to the Russian authorities to make the payment at the bank's account indicated by the applicant.
