The Government of the Republic of Bulgaria would like to report the following progress regarding the execution of the "UMO Ilinden group vs. Bulgaria" of ECtHR judgments:

By an Oder of the Minister of Justice's, dated 2 September 2024, a working group is established concerning the execution of the ECtHR's judgments in the "UMO Ilinden vs. Bulgaria" group of cases. The working group's task is to conduct a comprehensive analysis of the need for legislative amendments by March 2, 2025, and, if required, to propose such amendments in compliance with Article 11 of the Convention.

The first meeting of the working group took place on 11 September 2024¹. The meeting was chaired by the Deputy Minister of Justice, with participation of the representatives from the executive and judiciary powers as well as the academia.

At the first meeting, there was a presentation of the main findings of the ECtHR. The group also discussed the progress achieved in the execution of the abovementioned judgements under the supervision of the Committee of Ministers. During the discussion among the participants, it was decided on the further activities of the working group.

Taking into consideration the competence of the different participants, the Deputy Minister of Justice designated specific tasks. Those tasks included preparation of a comparative analysis of the legislation and registration procedures of the EU Member States, detailed statistics and concrete proposals for further action.

The subsequent meeting of the working group is scheduled for 5 November 2024.

The Government of the Republic of Bulgaria will provide further information to the Committee of Ministers in due time.
