- 1. The authorities would like to provide the following information on individual measures in the present groups of cases.
- 2. The *Alparslan Altan* and the *Akgün* groups of cases mainly concern violations of the right to liberty and security of the applicants, due to their pre-trial detention on suspicion of membership of a terrorist organisation.
- 3. The authorities would like to recall at the outset that, in the present cases, the Court limited its examination to the applicants' pre-trial detentions. The Court neither examined the context of the evidence obtained during the ongoing proceedings nor commented on the evidence leading to the convictions of the applicants.
- 4. Having explained the scope of the violations as such, the authorities would like to note that none of the applicants are currently subject to pre-trial detention. Furthermore, the applicants,

- except for those listed in the appended table, are not currently in prison. The applicants listed in the appended table are in prison due to their conviction (see appended table).
- 5. In light of this, the authorities are of the view that no further individual measures are required in this respect. This approach was also confirmed by the Committee of Ministers ("the CM") at the 1475th meeting of 19-21 September 2023 (DH) whereby the CM decided to close some other cases, which also concerns violations relating to the applicants' pre-trial detentions, jointly examined under the *Alparslan Altan* and *Akgün* groups. The CM considered that as none of the applicants were subject to pre-trial detention, it did not appear that any further individual measures were required.
- 6. Therefore, what remains for closure of supervision of individual measures is the payment of just satisfaction. The Committee will be provided with information in this respect.
- 7. The Turkish authorities will maintain submitting further information on the individual/general measures taken or envisaged to be taken in due time.
