I. CASE SUMMARY

The cases of the *Ignatov group* concern structural problems relating to arrest and pre-trial detention. They concern certain deficiencies in the legislation, in particular the 1960 Code of Criminal Procedure, replaced by a new Code in November 2012 ("the CCP"), but mainly problems in the application of that legislation by the relevant prosecutorial authorities and domestic courts.

The main problems identified in this group of cases are:

- (a) unlawful arrest and detention (including of a minor in the *Korneykova case*), in particular unregistered detention, delays in the drawing up of the arrest reports and the use of administrative arrest for the purposes of criminal investigation without safeguarding the detainee's procedural rights, in particular the right to a defence; arrests without a court order in the absence of the grounds set forth by the domestic law (Article 208 of the CCP); detention without judicial decision, including detention on remand without a court order between the end of the investigation and the beginning of the trial (in the Chanyev judgment (2015, §§ 34-35) the Court identified the need for legislative reform to resolve this problem); failure immediately to enforce court decisions ordering release; failure to state the relevant grounds when authorising detention on remand or to set a time-limit for such detention by the courts; pre-trial detention in excess of the maximum time-limit established by the domestic law (Article 5 § 1);
 - (b) failure to inform the individual promptly of the reasons for arrest (Article 5 § 2);
- (c) failure to bring the arrested person promptly before a judge; failure to advance relevant and sufficient grounds for extending detention on remand and/or 24-hour house arrest by using a standard formula merely listing the grounds for detention without addressing the specific facts of the applicants' case or to consider any alternative preventive measure; failure to provide relevant and sufficient justification for the decisions setting bail and its amount (Article 5 § 3);
- (d) lack of a clear procedure in the legislation to allow speedy and thorough review of the lawfulness of detention on remand, including due to the unavailability of the case files (Article $5 \ 4$); and
- (e) lack of a remedy capable of providing compensation for the above breaches (Article 5 § 5).

Some cases also raise other issues, including regarding the length of criminal proceedings (Article 6 § 1), the general measures in respect of which are examined in other groups.

INDIVIDUAL MEASURES

The Government would like to note that updated information on the payment of the just satisfaction awarded by the Court and regarding current individual situations of the applicants is provided in the *Annex I to* this *Action Plan*, respectively.

The Government would like to point out that at present the national authorities take measures in response to the Committee of Ministers' long-lasting calls to resolve the issue of payment of just satisfaction to a special deposit account by making the sums available to the applicants for a period longer than one year before they are transferred back to the state budget in order to comply with the unconditional obligation under Article 46 § 1 of the Convention to pay the just satisfaction awarded by the European Court.

The draft law of Ukraine "On Amendments to Certain Legislative Acts on Strengthening the Protection of Human and Civil Rights and Freedoms during the Enforcement of Decisions" was registered in the Parliament of Ukraine under No. 10389 of 03 January 2024¹. The draft law provides amendments to the Law of Ukraine "On Enforcement Proceedings" in the part of keeping sums awarded by the Court on the Ministry of Justice of Ukraine special deposit account if the applicants have not received such sums within the time limit set for the payment. In particular, the one-year period from the date of transfer of sums from the special deposit account to the State Budget provided by the current legislation will be extended to *five years*.

The Government consider that the adoption of these amendments into national law will ensure the compliance with the Committee's practice to consider "payment" as meaning the "placement (of the sums due) at the disposal" of the beneficiary, by any method whatsoever, provided that it is reasonably efficient. The sums will be at the applicants' disposal for a sufficiently long period (five years).

The Government will keep the Committee of Minister informed about further developments as regards the above draft law, including in communications in other cases/groups of cases.
