REGARDING RULE 9.1 COMMUNICATION IN CASE AL-HAWSAWI V. LITHUANIA (NO. 6383/17)

The Agent of the Republic of Lithuania before the European Court of Human Rights confirms the receipt of the communication from the applicant's representative of 5 June 2025, concerning the execution of the judgment in case *Al-Hawsawi v. Lithuania* and informs that it was brought to the attention of competent authorities for this purpose also organizing an inter-institutional meeting with the representatives of the General Prosecutor's Office and the Ministry of Foreign Affairs. The comments of the applicant's representative will be analysed within the course of the further actions aiming to implement the Court's judgment.

Execution process in the case at issue is a complex one requiring involvement of various institutions also it needs cooperation of foreign jurisdictions, some of the initiatives needed more time due to political changes after the Parliamentary elections and formation of the new Government. The Lithuanian authorities adhere to their commitment to execute the Court's judgment in the case at issue, the Committee of Ministers will be provided with the updated action plan in due time in accordance with the deadline indicated in its last decision.
