Dear Mr Pushkar,

With reference to your letter of 22 August 2019 about individual measures taken in the cases of Yeryomina and others v. Ukraine (application no. 30510/18), Kanna and Tsyganok v. Ukraine (application no. 24751/10) and Balakirev and others v. Ukraine (application no. 61109/10) concerning excessive length of criminal/civil proceedings please be informed of the following.

On 02 and 05 September 2019 the Agent before the European Court of Human Rights requested the latest information on the abovementioned cases from the national courts considering those cases as well as from the Supreme Court.

1. As to the case of Yeryomina and others v. Ukraine (application 30510/18)

As regards the decision of the Appeal Court of Odesa Region of 03 April 2012 the criminal case of Antypova L.F. (application no. 31773/18) was returned to the Malynovskyy district prosecutor's office of Odesa for additional investigation. Since then the court still has not received the case for a consideration.

According to the information, received from Saksaganskyy District Court of Kryvyy Rig on 09 March 2019 the case of the Yeryomina M.G. (application no. 30510/18) was referred to the Kryvyy Rig prosecutor's office of Dnipropetrovsk Region for additional investigation. The court has not received the case for a consideration yet.

In view of the abovementioned additional requests were sent to the Malynovskyy district prosecutor's office of Odesa and Kryvyy Rig prosecutor's office of Dnipropetrovsk Region.

According to the information, received from the Lysychansk Local Court of Luhansk Region the hearing in the case of Tokar V.M. (application no. 39273/18) is scheduled for 04 October 2019. Міністерство юстиції

2. As to the case of *Kanna and Tsyganok v. Ukraine* (application no. 24751/15130-19/5.2.2 від

3. As to the case of Balakirev and others v. Ukraine (application no. 61109/10)

The case of Kosayeva S.D. (application no. 33773/18) has been pending in the Ordzhonikidzevskyy District Court of Zaporizhzhya since 2005. The next hearing of the case is scheduled for 21 October 2019.
