Referring to the decision of **CM/Del/Dec(2019)1340/H46-7** in **Gazsó group v. Hungary (Application No. 48322/12)**, the Government of Hungary have the honour to submit the following information:

The Government intend to prepare a revised draft concept concerning the introduction of a domestic remedy in connection with the excessive length of proceedings in criminal matters, which meets the requirements of the European Convention on Human Rights and the case law of the European Court of Human Rights.

The Government will take into account the observations of the Secretariat on the issues that appear to raise questions of conformity with the Convention and the European Court's case law.

The draft concept will be submitted by the Government to the Secretariat by the end of 2019 in order to request a preliminary assessment of the Secretariat.
