Candidatures	The President of the Congress will be elected from among the representatives of the Congress sitting in the Chamber of Local Authorities. If candidates are: president of a political group [Rule 11.3.a] chair or 1st vice-chair of a committee [Rule 47.12.a] thematic spokesperson [Rule 63.2] they will have to immediately resign from these positions if elected. All candidates must speak English or French fluently. Only candidates who signed the Code of Conduct and the Declaration of Interest may submit their candidature.	Only representatives sitting in the Chamber and who do not belong to the same national delegation as the President of the Congress, may stand for election for the office of President of the Chamber. Candidates may not: have served 2 consecutive terms as President of that Chamber immediately before the election If candidates are: president of a political group [Rule 11.3.a] chair or 1st vice-chair of a committee [Rule 47.12.a] thematic spokesperson [Rule 63.2] they will have to immediately resign from these positions if elected. All candidates must speak English or French fluently. Only candidates who signed the Code of Conduct and the Declaration of Interest may submit their candidature.	Only representatives of the Congress sitting in the Chamber may stand for election as vice-president of a Chamber. If candidates are: president of a political group [Rule 11.3.a] chair or 1st vice-chair of a committee [Rule 47.12.a] they will have to immediately resign from these positions if elected. Only candidates who signed the Code of Conduct and the Declaration of Interest may submit their candidature.

Conditions	Even if there is only one candidate to the post of President of the Congress the election must be by secret ballot (which may be held electronically) [Rule 14.3]. A candidate to the post of President of the Congress [] is elected if more than half of the votes cast are in his or her favour. If this is not the case, a new election must take place as follows: a. with regard to the post of President of the Congress, candidatures must be presented to the Secretary General of the Congress in accordance with Rule 13.2.a and 13.2.c, within four hours of notification of the result of the election to Congress members by the provisional President. The new election shall be held as soon as possible thereafter and preferably before the end of the session. [Rule 14.4]	Even if there is only one candidate to the post of President of a Chamber the election must be by secret ballot (which may be held electronically) [Rule 14.3]. A candidate to the post of [] President of a Chamber is elected if more than half of the votes cast are in his or her favour. If this is not the case, a new election must take place as follows: b. with regard to the post of president of a chamber, candidatures must be presented to the Executive Secretary of that chamber in accordance with Rule 13.3.b within one hour of notification of the result of the election to that chamber's members by the provisional President. The new election shall be held as soon as possible thereafter and preferably before the end of the chamber session. [Rule 14.4]	An election must take place even if there are fewer than seven candidates. A delegate entitled to vote may vote for up to seven candidates and must vote for at least four. The seven candidates receiving the greatest number of votes are declared elected in each chamber in order of precedence according to the number of votes each receives. [Rule 14.6] A candidate for the office of vice-president is eliminated from election if a representative belonging to the same national delegation has already been elected as president of the Congress or of that chamber. [Rule 14.7] If more than one representative from the same national delegation is candidate to be vice-president of the same chamber, only the representative with the highest number of votes can be declared elected. In the event of a tie between several candidates, lots shall be drawn. [Rule 14.8] If more than one representative from the same national delegation is candidate to be vice-president of the two chambers, only the representative with the highest percentage of votes is declared elected. In the event of a tie between several candidates, lots shall be drawn. [Rule 14.9]

Conditions	IF THERE IS ONLY 1 CANDIDATE: the candidate is declared elected without proceeding to a ballot UNLESS a ballot is requested by at least 10 representatives from at least 4 national delegations. Where a ballot is requested, it shall be held immediately, be secret and provide for votes in favour, against or abstention IF THERE IS MORE THAN 1 CANDIDATE:	An election must take place even if there are fewer than four candidates. A committee member may vote for up to four candidates but must vote for at least three. The vice-chairs are to be declared elected in order of precedence according to the number of votes each receives, except that no candidate may be declared elected as 4th or 5th vice-chair if four persons of the same gender as that candidate have already been elected as
	- A candidate is elected if they receive more than half of the votes cast	chair or vice-chairs of that committee.
	 If they do not receive more than half of the votes cast an additional round shall take place until one candidate has obtained more than half of the votes cast. At each round the candidate who has received the least number of votes shall be eliminated.
