# Road map and Terms of Reference for the Committee of Experts to Study the Progress of the Execution of the Bekir Ousta and Others v. Greece group of Cases L'execution (No. 35151.05)

#### I. Introduction

1. The present text was developed and agreed by the members of the Committee of Experts to Study the Progress of the Execution of the Bekir Ousta and Others v. Greece group of cases (No. 35151.05). It contains a proposed road map and terms of reference for the Committee for the period from its first session, held in Athens on the 12<sup>th</sup> of June 2024, to its session after one year, to be held on June 2025, with a view to facilitating the fulfilment of the Committee's mandate through a well-planned, organized and transparent approach.

2. The proposed road map (see the table below) has been prepared in accordance with the time frame established in the schedule for the negotiating and sessions of the Committee that was circulated by the Chair on 12<sup>th</sup> of June 2024 and subsequently modified in accordance with most recent deliberations of the members of this

Committee.

## II. Terms of Reference for the Committee

#### A. General

The purpose of the Committee is to Study the Progress of the Execution of the Bekir Ousta and Others v. Greece group of cases (No. 35151.05) following the substantial and productive talks that Deputy Minister for Foreign Affairs Mrs. Papadopoulou held on 8<sup>th</sup> November 2023 in Athens, in the MFA's premises, with the Delegation of the Council of Europe Secretariat, headed by Director of Human Rights Mr. Poirel, and composed of members of the Department for the Execution of Judgments of the European Court of Human Rights.

By taking into account the experiences of the three independent members of the Committee in key thematic areas such as constitutional law, civil rights and liberties, protection of human rights, social exclusion and discrimination issues, specialized public law, humanitarian and international law, as well as the interrelationship of the relevant with the issue articles in domestic law, it is proposed that a draft document compiling the experts' initial proposals for a way forward be prepared to serve as the basis for the work of the Committee at its following sessions. At a later stage, a consolidated document will be prepared on the basis of the outcomes of the sessions and the research by the members of the Committee.

In advance of the sessions of the Committee, relevant stakeholders will be requested to provide to the Committee draft texts or provisions that are to be examined at those sessions. These consultations will be scheduled between the sessions of the Committee, bearing in mind that participation in the work of the Committee by multistakeholders does not entail negotiation and drafting roles, which are the exclusive prerogative of this Committee.

At the end of each session, the Committee may, if necessary, readjust the timetable in accordance with the progress made to date.

# B. Aims & Objectives

- 1. Exchange of information in written on the issue and proposals as a way forward.
- 2. Provide a framework for the discussion and promotion of best practice and share the latest research and evidence for best practice on the issue.
- 3. Collaboration with other relevant stakeholders to analyse and evaluate the specific aspects of the issue identified by the Committee by means of exchanges of information and experiences (reporting) and thematic visits.

#### C. Responsibilities

Each Committee member shall take an active part in undertaking agreed tasks in between the meetings as appropriate.

To make the most effective contribution each committee member shall:

- 1. Attend all committee meetings including the sessions of the Committee
- 2. Take an active and constructive part in committee discussions and decision making, and accept a share of the responsibilities for conducting its tasks
- 3. Conduct all business in a professional independent manner to assist in the promotion of the aims and objectives of the Committee

# D. Funding for Committee Members

Committee members may claim expenses for doing so. The Government of Greece will, upon request, bear the travel and subsistence expenses of the members of the Committee.
