**VCL and AN v the United Kingdom (Application No. 77587/12 and 74603/12)**

I am writing to update the Committee of Ministers further to the Decisions adopted on 19 September 2024 (reference CM/Del/Dec(2024)1507/H46-42) relating to the execution of the above judgment of the European Court of Human Rights, which refer to the potential impact of recent legislation.

Following the result of the General Election on 4 July 2024 and acting on a clear manifesto commitment, the Government of the United Kingdom has announced that it will be ending the migration partnership with Rwanda. Consequently, the Government is considering all options and implications linked with ending the partnership with Rwanda. This includes the Illegal Migration Act and its implementation.

I will keep the Committee informed of further developments as they arise, before the next full update which is to be submitted by 1 May 2025.
