**47th Congress Session  
Strasbourg, plenary sittings 15-17 October 2024  
Abridged report – list of items discussed and decisions taken**

1. The President of the Congress, Marc COOLS, opened the 47th Session. The list of participants appears in Appendix 1.
2. The Congress adopted Resolution 501 on the *Verification of new members' credentials*, as set out in document CG(2024)47-02, presented by the co-rapporteurs Andrew BOFF, United Kingdom (R, ECR), and Martine DIESCHBURG-NICKELS, Luxembourg (L, ILDG) .
3. The Congress adopted the revised agenda as set out in Appendix 2.
4. The Congress adopted the minutes of the last sitting of the 46th Session (28 March 2024) as set out in Document CG(2024)46-PV-03.
