NATIONAL ACTION PLAN TO COMBAT IKB IN ITALY WAS FOCUSED ON FIVE MAIN GOALS:

1. Strengthening direct law enforcement of illegal activities against wild birds;
2. Strengthening indirect enforcement;
3. Prevention of wild-bird crimes;
4. Monitoring the implementation of the plan;
5. Setting up of a National Steering Committee (“cabina di regia”).

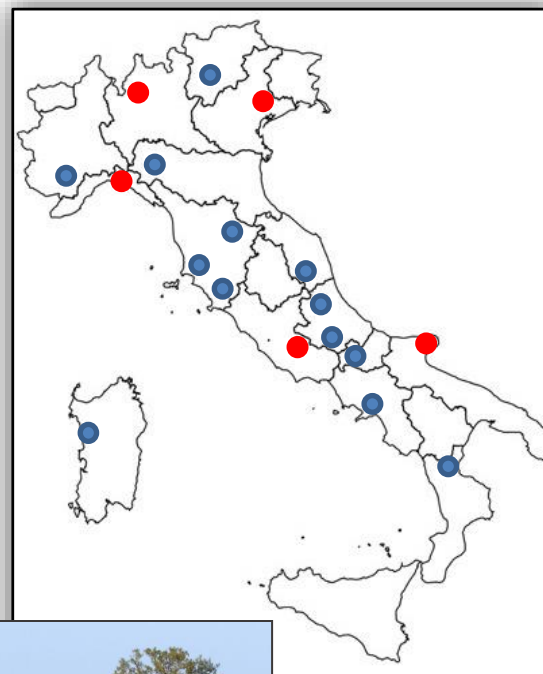
