The final version of the "Vision for de Boschplaat" is send to de Council in 2022. The Natura 2000 management plan ended in 2022 and is extended for three more years. The new Natura 2000 management plan in which the "Vision" should be incorporated, will be made by the Province of Friesland. It is planned for the year 2024/2025.

2. review annually the grazing in De Groede, and adjust its intensity and the boundaries of grazing areas as necessary so as to retain the biodiversity value of this section of De Boschplaat Nature Reserve;

This year the intensity of grazing was higher than the years before, although it still falls within the agreed conditions. The normal grazing pressure is yearly around 0,3 cows/hectare. Because the vegetation in a part of the Groede is getting rougher, we are working on a plan to put a higher grazing intensity in this part, combined with no grazing in an other part during the first half of the breeding season.

3. assess the requirements for additional financial resources to undertake targeted and time-limited research, monitoring and educational activities:

This continues to be a yearly search. Because Staatsbosbeheer doesn't have sufficient resources, the question raised by the provincial management team in what way we are obliged to do monitoring of flora and fauna. Our team has emphasized that the Boschplaat is an important natural area and that it is necessary to monitor to see what developments are, to intervene in time.

On the other hand we started with planning the "Vision of the Boschplaat". We have a lot of contacts with scientists and universities in the Netherlands to do research on the Boschplaat and on the new measures to be taken (washovers, drifting dunes, grazing). An important part is to do a start-monitoring in advance. Also the cultural aspects will be involved.

4. devise a strategy for the management and control (or eradication) of invasive alien species on De Boschplaat to be included in the future management plan;

Staatsbosbeheer is working on a plan to eliminate and/or control invasive species on the island of Terschelling. We do that together with de local authorities.

5. maintain contact with all agencies involved in marine accident prevention and, if an incident does occur, with agencies involved in the minimisation of the effects of the accident on De Boschplaat;

This is an ongoing process. Together with Rijkswaterstaat a contingency plan is made to protect the Boschplaat is case of for example an oilspill. We are in contact about fine-tuning this plan because of the presence of the channels that make preventing pollution more difficult.


In spring 2023 we placed a new information panel at the entrance of the Boschplaat. Rules a re in three languages. Online information still needs to be updated.

In relation to the "Vision on the Boschplaat" the province of Friesland made an investigation of the N2000 of the effect of coastal erosion on the N2000 habitattypes in the area. The conclusion is that there is a decrease of certain important habitats on the Boschplaat, but on the larger Wadden sea scale the area of these habitats is increasing. It is part of the natural dynamics. Therefore there is no reason the react on the erosion, for example by a beach nourishment.

The financial situation according to surveillance and monitoring is under pressure. Staatsbosbeheer is planning to do only the specific tasks which have financial coverage by the province or ministry of LNV. Large parts of the supervision and public guidance are not financed through a sustainable way and rely on occasional projects, such as "Wij en Wadvogels". This year we managed to create and implement a new zoning plan around the breading area, financed by this project.

The zonation of the recreational activities still needs attention. The earlier reported use of so called fatbikes on the beach and the walking path stopped because rental companies don't have them anymore. Outside the management area of Staatsbosbeheer we see an increase of recreational activities. A local company has started to do boat excursions on the Waddensea, sometimes close to the Boschplaat. Staatsbosbeheer reacted on the licence application which was submitted to the province of Friesland, to stop this activity. Mainly because of disturbance of resting birds (on the water and on the shore) and noise disturbance in this quite area. None the less the boat trips are allowed now.

Special breeding birds

We are happy to report that in 2023 for the first time in years we found a breeding Whinchat. This bird is a Natura 2000 species of which the national population is declining over the years. Other noteworthy breeding

birds are one pair of red-breasted merganser and at least one pair of short-eared owls. Also we finally have two breeding pairs of the sand plover, after several years of absence.
