Statement of EUROGEO to the 11th Council of Europe Conference on the European Landscape Convention

EUROGEO is the European Association of Geographers, a membership-based professional society. The principal aims of EUROGEO are to advance the status of geography by organising conferences, undertaking research projects, producing scientific publications, supporting geographers in their jobs and careers, identifying and promoting good practice, and making recommendations to decision makers.

EUROGEO has more than 5,000 individual members from all European countries and beyond, and about 300 organisation members, including most University Geography Departments, National Geographical Societies and professional bodies. EUROGEO is the network of geographers in Europe, but other related fields like cartographers (GIS, remote sensing), urban planners, surveyors, environmentalists, and landscape professionals.

Since 1989 EUROGEO has participatory status in the Council of Europe, with an active participation at the Conference of INGO's, and in particular at the Democracy, Social Cohesion and Global Challenges Committee, and Education and Culture Committee. In 2017 UN ECOSOC granted EUROGEO special consultative status for United Nations. Since then, EUROGEO has been also an active member of the UN-Habitat system (Governing Council, Word Urban Forum, World Urban Campaign, Habitat Professionals Forum), and particularly for the dissemination and implementation of the New Urban Agenda, which highlights the importance of landscape protection, management and planning for urban sustainable development.

Therefore, EUROGEO encourages to the States who signed and ratificated the European Landscape Convention to strengthen links between geospatial technologies, citizenship education and landscape protection to raise global awareness on challenges like sustainable development and climate change mitigation. Geography is the interdisciplinary science of settlements, and European geographers, as educators or professionals of earth landscapes, are engaged to spatial analysis on landscapes evolution, but also to provide solutions. Many European projects run by EUROGEO, but in particular Geoland (Digital Educational Geoinformatics Methodologies for Monitoring Landscape) are exploring educational procedures for the effective participation of Higher Education students in decision-making for landscape management, which will contribute to these global challenges.

Intervention on Green & Healthy Destinations and the healing force of landscapes for the 11th Council Europe Conference Landscape Convention, 26 May 2021

President, ladies and gentlemen, is a privilege and honour for me to address your Conference, and it brings back memories of the times that I was actively involved, also a president, in the Pan-European Biological and Landscape Diversity Strategy.

On 29 April this year, the Foundation Nature for Health and Green Destinations were glad to organize the international seminar 'Green & Healthy Destinations – the healing force of landscapes', with Maguelonne Déjeant-Pons as key note speaker.

The seminar highlighted the importance of landscapes for human health and well-being and landscape related tourism, especially in the light of the challenges COVID-19 brought to our societies. The seminar marked the start of the development of a European Inspiration and Learning Network for Green & Healthy Destinations.

The onset of the COVID-19 pandemic catalyzed changes in our lifestyle and travel patterns and resulted in increased use of landscapes closer to our homes. As our physical and mental well-being has been impacted by the epidemic, finding safe green and healthy destinations where our mind and body can heal is much needed. Also tourists are reappraising their preferences for holiday destinations where they could combine safe leisure activities with activities that contribute to their health and well-being. Consequently, more and more destinations are reassessing their development strategies by boosting initiatives that integrate leisure and landscape-based health activities.

The European Inspiration and Learning Network for Green & Healthy Destinations aims to exchange experiences, views and expertise between destinations on the integration of leisure, nature, landscapes and healthcare. Moreover, exploring together the possibilities for cross-sectoral collaboration between sectors of tourism, health and landscape management will help to facilitate shifting leisure to be a more healthy, affordable, and well-being-enhancing experience. The Network can help to remove the high fences between sectors such as leisure, health care and landscape management.

The seminar highlighted some truly inspirational examples where regions are utilizing nature and landscapes for leisure and health both, in particular Gesundland VulkanEifel in Germany and London National City Park in the United Kingdom. The seminar also highlighted the determination of the Van Gogh National Park in the Netherlands to become a healing landscape of international importance.

In conclusion, we think the time is ripe to further integrate leisure, health and well-being as part of the implementation of the European Landscape Convention and to promote the healing force of landscapes as a vital aspect of green & healthy destinations across Europe. We hope that the Conference for the European Landscape Convention will endorse the initiative of European Inspiration and Learning

Network for Green & Healthy Destinations and work with us to turn the Network into a success, for the sake of people and landscapes and the health of both.
