# 1. Opening of the meeting by the Chair

The meeting was opened by the Chair, Ms Flora van Regteren Altena (the Netherlands), who welcomed the participants who had travelled to Strasbourg and those connecting on-line to the 11<sup>th</sup> plenary session of the CDCPP (see List of Participants in Appendix I). This was the first meeting of the Committee without the presence of the Russian Federation and Belarus, following the <u>decision of the Committee of Ministers of the Council of Europe</u>.

The Director of Democratic Participation, Matjaž Gruden also greeted the participants, explaining that the cessation of the membership of the Russian Federation from the Council of Europe following its aggression towards Ukraine would have consequences on the sector's budget. However, on a positive note, the *Enlarged Partial Agreement on Cultural Routes* would benefit from an increased budget, thanks also to a voluntary contribution from France. In addition, the *EUR-OPA Major Hazards Agreement* had met with success in providing elements for the countries to agree on increasing their contributions to continue funding the programme. The Director thanked the member States for their political and financial support for the sector's activities in these challenging times.

As far as recent staff changes in the Department of Culture, Nature and Heritage were concerned, both Maguelonne Dejeant-Pons (landscape) and Kathrin Merkle (culture) had now retired, in June and October respectively. This left two key posts currently unoccupied, one of which would be suppressed entirely, as a consequence of the early retirement scheme. In order to address the immediate challenges of ensuring the continuation of the many activities with fewer staff members, the Director had appointed Francesc Pla to take over Kathrin's role as Secretary to the CDCPP and asked Gianluca Silvestrini to help prepare an adjusted programme and budget.

Posts and tasks in the Department would inevitably have to be reconsidered for optimum efficiency: a Head of Department corresponding to an A5 post would be reinstated, with an A4 post as deputy. The A5 post would also have operational responsibilities, aiming to ensure a more integrated approach visà-vis all the departmental activities, as reflected in the philosophy behind the "LINKED" document [CDCPP(2022)5]. Another important note was the nomination of a new *European Heritage Days* Manager, Sergei Bazarya, who had taken up his duties in the summer.

In view of all these changes, the Committee's Terms of Reference would also need to be monitored and adjusted as appropriate, according to the challenges and the available human resources.

The Chair of the Committee expressed her regret at the departure of two key staff members, from both a personal and professional point of view, and thanked them most sincerely for their tireless work, commitment, enthusiasm and innovative thinking over the past few decades. Many other delegations joined the Chair in expressing their great appreciation and thanks for the work of Maguelonne and Kathrin over the years in landscape and culture.

### 2. Adoption of the agenda

The Committee adopted the agenda, as it appears in Appendix II.

# 3. Elections [document CDCPP(2022)1]

The Secretariat explained that the Committee would need to elect i) a Chair with a mandate running from 1 January 2023 to 31 December 2023; ii) a Vice-Chair with a mandate running from 1 January 2023 to 31 December 2023; iii) five Bureau members with 2-year mandates running from 1 January 2023 to 31 December 2024; and iv) one Bureau member with a one-year mandate running from 1 January 2023 to 31 December 2023.

4. Council of Europe Conference of Ministers of Culture on "Creating our future: creativity and cultural heritage as strategic resources for a diverse and democratic Europe" (Strasbourg, 1 April 2022)

# Working Group to develop guidelines, given the latest technological developments (such as Artificial Intelligence) complementing Council of Europe standards in the fields of culture, creativity and cultural heritage [document CDCPP(2022)2]

Delegates welcomed the proposal for a concrete follow-up to the Ministerial Conference of April 2022, in the form of a Working Group to develop guidelines, given the latest technological developments (such as Artificial Intelligence) complementing Council of Europe standards in the fields of culture, creativity and cultural heritage. The Committee discussed the particular focus they would envisage for the Working Group and Guidelines and agreed to propose appropriate experts to participate in the group by 15 January 2023. The CDCPP requested its Bureau to approve the terms of reference of the Working Group and to set up the group accordingly, with due consideration for geographical and gender balance.

# Follow-up to the <u>Declaration on the Russian Federation's aggression against Ukraine</u> [document 2022)3]

The Chair of the Committee warmly welcomed the Deputy Minister for Culture and Information Policy of Ukraine, Kateryna Chuyeva. Speaking from a shelter following an air raid in the capital, the Deputy Minister thanked the delegates for their support in these times of crisis. Unstable electricity and water supplies were making it difficult to communicate and the usual working methods needed to be rethought and reframed. Support for Ukraine was vital, when some people were not even receiving their salaries and where much of the country's cultural heritage had already been damaged by the Russian invasion, or else remained under severe threat. Financial support, fellowships, training, digitalization of collections were among the help that could be envisaged.

Delegations all expressed not only their profound and heartfelt sadness, but also their unanimous and unerring solidarity with the Ukrainian people. Some delegations (Croatia and Bosnia-Herzegovina) with recent experience of conflicts offered to share their experiences and practical advice.

Many delegations reported on the assistance they were already giving to Ukraine to help protect its rich cultural heritage. The message from all the participants was to urge Ukraine to continue fighting for liberty and to never give up in this absurd and intolerable war.

The CDCPP thanked Ms Chuyeva for her emotive intervention and first-hand information on the actual urgent needs of the culture and culture heritage sector in Ukraine. It welcomed the preparation of the Council of Europe Action Plan for Ukraine "Resilience, Recovery and Reconstruction" 2023-2026, where culture, heritage and landscape actions are explicitly considered, and it supported further consultations with the Ukrainian authorities to fine-tune the suggested activities, taking into account funding opportunities and ongoing initiatives at various levels.

# 5. "LINKED" – Guiding principles for an integrated culture, nature and landscape management [document CDCPP(2022)5]

The Vice-Chair, Terje Birkrem Hovland presented the working document on the Guiding principles for an integrated culture, nature and landscape management. Professor Rodney Harrison also provided supplementary information via a short video message addressed to the delegations.

The CDCPP exchanged on the text, praising its soft and non-imposing holistic approach to the issues. There was wide consensus that the way we live needs to change to include sustainable lifestyle considerations in our national policies, with a greater inclusion of the cultural dimension. Similarly, two delegations specifically wished to see a better integration of the cultural sector and also intangible cultural heritage in the document. One observer representative commented that the split between culture, nature and landscape had not always existed and that this concept should be included in training programmes. One delegation also noted the possibility for enriching the document content in the future, considering for example cultural transfers linked to migration or the implications of destruction in armed conflict areas.

The CDCPP welcomed the draft Guiding Principles presented and, pending any further written comments to reach the Secretariat by 15 January 2023, agreed to adopt the Guiding Principles as a new Council of Europe instrument for inspired policy making, and encouraged its subsequent wide dissemination and application.

### Thematic Session – a decade of recommendations of the Council of Europe's Committee of Ministers in the field of culture, heritage and landscape – legacy and prospects [CDCPP(2022)6]

The Committee welcomed the organisation of the 2022 thematic session on the Council of Europe's ten years of recommendations in the field of culture, heritage and landscape, reflecting on the past and exploring how these instruments can assist in addressing future challenges.

The first part of the session took the form of an informal Round Table, with four key delegates from Finland, France, Italy and Switzerland approaching the topic from their own experiences of working in the culture, cultural heritage, digital technologies and landscape sectors over the years.

The second part generated a rich and lively debate among the delegates, some of whom affirmed the positive role that the Council of Europe recommendations played in their countries. The Council of Europe's responsiveness produced instruments that were relevant, topical and innovative. Together with the conventions, they created a unique European framework, providing practical guidelines and impetus for national and regional actors.

Several delegations and observers believed however that these instruments were not sufficiently wellknown and did not always have the impact they deserved. The important role of the CDCPP observers in disseminating the recommendations could be better exploited. The member States' delegations and ambassadors could also do more to deepen their knowledge of the recommendations in the field of culture, heritage and landscape and help spread the word.

Other ways to make these instruments more accessible were suggested, including some kind of laboratory process to look at the data and see whether a way could be found to improve impact. Indicators and a methodology might be identified in the process. Other ideas were suggested including translations of the texts, summer schools, better linkages with the other key Council of Europe bodies and the use of social media to improve communication and promote exchanges. A common dissemination strategy could be envisaged to enhance knowledge and understanding of the instruments.

As regards "soft monitoring", the thematic session was in itself a soft monitoring process that had definitely fostered a deeper reflection, and generated ideas about the purpose and success of recommendations in the field of culture, heritage and landscape.

# 7. Preparation of an implementation report on Recommendation No. R (2000)13 of the Committee of Ministers to member States on a European policy on access to archives [document CDCPP(2022)7]

Following a short update from the Secretariat and presentations from Michael Friedewald (Fraunhofer Institute) and Ivan Szekely (senior research fellow at the Open Society Archives), the CDCPP welcomed the preliminary findings that would feed into the implementation report on Recommendation No. R (2000) 13 on a European Policy on Access to Archives, further to the invitation from the Committee of Ministers.

The new considerations since 2003 included the issues of digitisation on demand, users' right to make own photos and scans, remote access, crowdsourcing, the use of artificial intelligence, new (born digital, ephemeral) documents.

As the draft study would only be available by the end of the year, the CDCPP decided to ask its Bureau to evaluate the content of the report at the beginning of 2023 before a written consultation with the members of the CDCPP, and prior to forwarding the results of the final study to the Committee of Ministers.

# 8. Drafting of a recommendation based on the EBLIDA Guidelines on Library Legislation and Policy in Europe [document CDCPP(2022)8]

Following a short update from the Secretariat on the process that had led to the present draft document, the Director of EBLIDA, Giuseppe Vitiello provided information about the new draft Recommendation with appended Guidelines, emphasising the huge importance of libraries in our democratic societies. Cultural and societal changes on the one hand, and technological developments on the other hand, are challenging libraries in new ways, hence the need for an update of the work carried out in the year 2000. In this respect, and to reflect today's challenges (covid pandemic, migration crises, sustainable development, AI, fake news etc), the current Guidelines have five sections: Freedom of expression, free access to information and democratic participation; Libraries within the framework of the European agenda on sustainable development; Global and local threats and library operations; Digital transformation and the promotion of a sustainable, reliable and inclusive library ecosystem; Copyright and the protection of library heritage. These different sections bring the document in line with the present-day context.

The CDCPP therefore welcomed the draft Recommendation on Library Legislation and Policy in Europe and supported the adoption of the text, pending any further comments to be sent to the Secretariat by 15 January 2023. In addition, some delegations suggested ways to ensure future wide dissemination and application of the Recommendation.

**9.** Eurimages – setting up of a new legal framework to codify the rules of European drama series co-productions [document CDCPP(2022)4]

The Eurimages Secretariat informed the CDCPP delegates about the latest developments regarding the creation of the new legal framework. Two meetings had taken place in 2022 to advance the drafting of a convention. Having circulated a revised version for comments, a final meeting would be held in April 2023 in Brussels to agree on the final draft document that would then be submitted to the CDCPP in summer. Under the Latvian Chairmanship of the Committee of Ministers (May-November 2023), an event would take place to assess the advancement on this legal instrument and on the associated financial instrument to be launched.

The CDCPP thanked Eurimages for keeping it informed on the developments of the working group and welcomed the rapid progress that had been made in drafting such a convention. It looked forward to examining the legal text at its 2023 plenary session in the autumn.

# 10. Fields of activity of the CDCPP

# **10.1 Cultural Heritage** [document CDCPP(2022)9]

### Council of Europe Convention on Offences relating to Cultural Property (Nicosia Convention)

The Secretariat of the Culture and Cultural Heritage Division of DGII (Directorate General of Democracy and Human Dignity) updated delegates on the latest developments regarding the Nicosia Convention. Following this intervention, the Secretariat of the Criminal Law and Counter-Terrorism Division provided information on the work being carried out in DGI (Directorate General for Human Rights and Rule of Law). The CDCPP welcomed the close collaboration between these two entities of the Council of Europe towards reaching the objectives of the Nicosia Convention.

The CDCPP delegates were reminded of the entering into force of the Nicosia Convention on 1 April 2022 and encouraged member States and non-member States of the Council of Europe to sign and ratify the Convention, translate and promote it as an open instrument at relevant European and international events.

### European Heritage Days

The Secretariat updated the CDCPP delegates on the latest developments in the European Heritage Days Programme. National Coordinator Hanna Hämäläinen, Planning Officer in the Finnish Ministry of the Environment, presented the Finnish experience of the Young European Heritage Makers, explaining the importance of the activity and how it can foster the formation of the cultural identities of children and young people and help them to build a relationship with their environment and heritage, and aid understanding and appreciation of local and European heritage.

The CDCPP welcomed the progress made in the implementation of the 2022-2023 European Heritage Days Programme and congratulated the network of EHD National Coordinators for the successful organisation of tens of thousands of European Heritage Days events. The Committee encouraged member States to participate in the 2023 European Heritage Days under the pan-continental theme of "Living Heritage". The delegates were keen to promote youth engagement in the European Heritage Days celebrations, as illustrated by the successful experience presented by the Finnish National Coordinator.

# European Cultural Heritage Strategy for the 21<sup>st</sup> century (Strategy 21)

The Secretariat of the Culture and Cultural Heritage Division updated the CDCPP on the latest developments regarding Strategy 21 and the Committee welcomed the progress made on its follow-up.

The CDCPP members agreed to participate in the implementation of Strategy 21, in particular by introducing it into national heritage strategies, by organising dissemination events and by adapting available promotional material into national languages accessible on national websites. They also committed to widely promoting the MOOC (Massive Open Online Course) at national/regional/local levels and to providing good practices/initiatives to facilitate exchange at national and international level.

# Faro Convention Action Plan and follow-up to the Joint Project "The Faro Way"

The Secretariat highlighted the ratification of the Faro Convention by Spain, Belgium and Poland as well as the development of new Faro national networks projects in Spain and Serbia. The topic of greater interaction between researchers and civil society had been addressed in a seminar organised in Bordeaux (France), while a regional seminar organised in Tallinn (Estonia) and a Spanish meeting bringing together national regional authorities had explored further steps in the implementation of the Faro Convention. Additional material on Faro initiatives was made available by means of a publication on selected examples of initiatives, and through the "Your Faro Way" online role-playing game.

The CDCPP welcomed the progress made and agreed to contribute to the continuous promotional work, particularly by disseminating materials translated into national languages and by supporting local, regional and national heritage initiatives applying the Faro Convention. It also acknowledged the importance of encouraging member States to sign and ratify the Faro Convention.

### HEREIN

The Secretariat of the Culture and Cultural Heritage Division updated the CDCPP on the latest developments regarding the thematic works on heritage and climate action and on historical gardens – two topics that could contribute to the "LINKED" efforts. A call for the updating of the existing data in the HEREIN information system was also launched in order for it to continue being a reference point for obtaining information on national policies.

The CDCPP welcomed the progress made on these various topics and acknowledged the potential contribution of the HEREIN Network to the CDCCP debates, through the collection and analysis of pertinent information. The Committee emphasised the need to engage with the activities and support efforts to consolidate the HEREIN project. Two delegations noted however that the HEREIN network should be revived through a greater interaction with the National Coordinators on specific topics.

# 10.2 Council of Europe Landscape Convention

Delegations and observers were all eager to pay a warm tribute to the exceptional work of Maguelonne Déjeant-Pons over the years. They also expressed their support and willingness to assist and cooperate with the Council of Europe to ensure the continuation of the excellent work carried out in the landscape sector and to keep the landscape convention activities moving forward. However, some delegations expressed their concerns about a possible future reduction in the activities of the landscape sector, in the face of reduced staffing in the Culture, Nature and Heritage Department.

The Secretariat thanked the CDCPP and observers for their much-appreciated support.

# The Committee also:

- took note of the request to nominate a representative to the International Jury panel of the Award by January 2023 and that an official invitation would be sent to the Chair of the CDCPP;
- took note of the setting up of a Working Group to prepare a draft recommendation for the attention of the CDCPP and the Committee of Ministers on "Landscape and Health";
- thanked the Hellenic authorities for their hospitality in holding the National Forum and the 6<sup>th</sup> Session of the Landscape Award, and took note of the <u>proceedings No 125</u> and also thanked the Italian authorities and the Foundation della Misericordia Maggiore for their hospitality in holding the 26<sup>th</sup> Meeting of the Workshops for the implementation of the Landscape Convention, and took note of the <u>proceedings No 124</u>;
- took note of the Council of Europe's <u>7<sup>th</sup> Session of the Landscape Award (2020-2021)</u> conferred to the "Biodiversity in the city: Bergamo and the Astino Valley, Foundation della Misericordia Maggiore of Bergamo, Italy";
- thanked the Armenian authorities for having organised the National Conference on the implementation of the Council of Europe Landscape Convention and took note of the proceedings No 126;
- took note of the Landscape education activities for primary schools and of the <u>Pedagogical</u> <u>booklet</u> available in twenty-two languages;
- took note of the "<u>Message from Strasbourg</u>" on the occasion of the Sixth International Landscape Day of the Council of Europe, 20 October 2022;
- took note of the holding of the 12<sup>th</sup> Council of Europe Conference on the implementation of the Council of Europe Landscape Convention in the Palais de l'Europe, Strasbourg on 25-26 May 2023;
- took note of the holding of the 27<sup>th</sup> Council of Europe Meeting of the Workshops for the implementation of the Council of Europe Landscape Convention in autumn 2023.

# 10.3 Culture

# Digital #Exhibition "Free to create, create to be free"

The expert curator, Katalin Krasznahorkai presented the latest developments concerning the digital #exhibition "Free to Create – Create to be Free" the aim of which is to contribute to the overall debate about the growing pressures on artistic expression. The Committee welcomed the successful development of the exhibition and encouraged further member States to contribute to it by providing in digital format, works of art that promote the freedom of expression and by providing additional support, including through voluntary contributions.

# Presentation and launch of the Council of Europe Report on the Freedom of Artistic Expression

Author Sara Wyatt presented the main findings of the report that examines the state of artistic freedom in Europe, seen also through the eyes of the artists themselves, and highlighting the various forms of restrictions they suffer. The report also looks at ways that the various stakeholders can address these diverse challenges to artistic expression. The Committee welcomed the report, agreed to disseminate it widely and asked the Bureau to consider appropriate follow-up.

The Committee welcomed the latest developments from the Association of the Compendium of Cultural Policies and Trends and the cultural policy information system, and thanked the experts Ulrike Blumenreich and Oliver Goebel for their interventions. It noted that the Compendium Association had launched a cultural policy research campaign on Artistic Freedom, a topic that had also been addressed by the Council of Europe since 2020.

# Publication – "E-relevance – the Role of Arts and Culture in the Age of Artificial Intelligence"

Through an artistic overview of the varied essays making up the above-mentioned publication, one of the editors, Vladan Joler, presented the actual and potential impact of AI, both positive and negative, on various aspects of culture and arts. The Committee greatly appreciated the lively presentation that illustrated in very practical ways the importance of AI in such domains, and delegates encouraged the large dissemination of the publication.

# 11. Information concerning other Council of Europe activities in the fields of culture, heritage and landscape

# Enlarged Partial Agreement (EPA) on Cultural Routes.

The Executive Secretary of the EPA on Cultural Routes, Stefano Dominioni, informed the CDCPP that three new cultural routes had been certified and that a further 14 evaluations of existing routes had taken place in 2022. He told delegates that the Partial Agreement had recently benefitted from a large increase in its general budget as well as from further voluntary contributions. He noted the successful annual Forum held in Crete with the support of the Greek authorities. The CDCPP appreciated the variety of activities developed and expressed its support to further developments.

# Parliamentary Assembly of the Council of Europe.

The Secretary of the Sub-Committee on Culture, Diversity and Heritage, Dana Karanjac, recalled two ongoing reports of relevance to the work of the CDCPP, namely "The Cultural Routes: a platform for intercultural dialogue" and "The role of sites of remembrance: places of commemoration and education for democratic citizenship". She also informed the CDCPP of two future reports addressing respectively cultural heritage and climate change, and countering the erasure of cultural identity in war and in peace. Finally, she stressed the PACE's wish to reinforce the link between culture, human rights and democracy. Such mainstreaming in other sectors could be based on previous PACE reports on culture democracy, cultural rights and identities.

### 12. Information on EU and other co-operation

### European Commission

The representative of the DG-EAC, Pia Sopta, informed the CDCPP that their 2023-26 Work Plan would soon be adopted, and highlighted their action in support of Ukraine. Two expert groups on strengthening cultural heritage resilience for climate change and on cultural dimensions of sustainable development had published their respective reports and an interactive guide on funding available at EU level for culture had been created. The New European Bauhaus placed particular emphasis on local communities' participation and reconnection to nature – topics related to the Faro and Landscape Conventions.

# European Cultural Centre of Delphi

After recalling its history and goals, the president of the European Cultural Centre of Delphi informed the Committee about the launch of the Delphi International Network Forum that fosters cultural exchanges through the promotion every year of the cultural traditions of both a European and a non-European country, and the Delphi Dialogues bringing together eminent thinkers to explore topical subjects. He also pointed out the educational and research role of the Delphi Academy of European Studies and expressed the desire for increased and enriched collaboration with the Council of Europe in the future.
