Joint Submission by GENDERDOC-M and ILGA-Europe¹ to the Committee of Ministers of the Council of Europe in the case GENDERDOC-M v Moldova no. 9106/06, judgment of 12 June 2012

The case concerns the banning of a demonstration by GENDERDOC-M in Chisinau in May 2005 (violation of Article 11), lack of effective remedy (Article 13 in conjunction with Article11), and discrimination (Article 14 in conjunction with Article 11).

In its Decision of 24 September 2015 the Committee of Ministers

"invited further the Moldovan authorities to provide information on the number of notifications for holding events similar to the one in the present judgment, preferably submitted between 1 June 2008 and 1 June 2015, and the number of court disputes between the local authorities and the organisers in such cases, as well as their outcome,.....;"

In its revised action report of 9 January 2017 the Moldovan government replied:

"Statistics concerning events organised by the LGBT community

11. As concerns the number of notifications for holding events similar to the one in the present judgment, according to the information provided by the Chisinau City Hall, in 2012-2016 there were 17 notifications submitted by the LGBT community and related organisations on holding pride demonstrations as well as other type of public events. For details please see the Annex."

The attachment to this communication presents an analysis of these events. It will be seen that, of the 17 listed, 11 were not "similar to the one in the present judgment". Of these, 10 were neither to do with LGBT rights, nor organised by an LGBT organisation, while one (no 10) only involved two LGBT activists, so that no prior notification was required. That leaves six which were, arguably, "similar events", in respect of which the following analysis is relevant:

It should be noted that the two events in the "application accepted - no subsequent issues" category were different in kind from the other four events. They were static events, rather than marches. So far as marches are concerned (and taking account of the 2017 Pride march²), Moldova's LGBT community continues to be denied full enjoyment of the right to freedom of assembly, as documented in previous communications (see Attachment for references).
