## LIST OF DECISIONS

At its second meeting, the Group of Specialists on child-friendly justice (CJ-S-CH), in accordance with its terms of reference,

*took note of:*

- the final version of the compilation of legal texts prepared by the Secretariat;
- the current activities of the Council of Europe Programme "Building a Europe for and with Children" including the setting-up of a new *ad hoc* advisory group on the topic of violence against children;
- the Document CJ-S-CH (2009) 7 BIL rev enclosing "Proposals concerning the consultation process on the draft guidelines";

*welcomed, examined and updated:*

- the 1st draft of the Guidelines on child-friendly justice prepared by the Scientific Expert in co-operation with the Secretariat (Document CJ-S-CH (2009) 10 (restricted));
- the Draft terms of reference of the CJ-S-CH for 2010 (Document CJ-S-CH (2009) 12 BIL)

*considered:*

- how best to consult children on child-friendly justice with a view to taking their views into account in the Council of Europe's guidelines;
- the opportunity of preparing a questionnaire aimed at consulting children on child-friendly justice to be examined at the next meeting of the Group;

*instructed the scientific expert to:*

- prepare a 2nd draft of the Guidelines and a 1st draft explanatory memorandum, along the lines agreed to at the meeting and incorporating the points made during the discussions by mid October 2009;

*invited its members to:*

- use the collaborative space created on the website of the CJ-S-CH for further internal work on the guidelines;
- make available their comments on the 2nd draft of the guidelines by publishing them in the documents on the collaborative space, at their earliest convenience, in view of the hearing planned on 7 December 2009;
- formulate their comments in the most concrete way possible, preferably in track changes in the draft text and by making when possible proposals for the wording;

*instructed the Secretariat to:*

- post the 2nd draft of the guidelines on the CJ-S-CH's website at its earliest convenience for comments by the members of the Group;
- invite all relevant NGOs and stakeholders to the hearing scheduled on 7 December 2009;
- make the 2nd draft of the guidelines as revised in the light of the specialists' comments available on the CJ-S-CH's website before 22 November 2009 for consultation by NGOs and other stakeholders in view of the coming hearing;

*decided to:*

- put the examination of the 1st draft explanatory memorandum of the guidelines, which should contain examples of good practice and references to the case law of the European Court of Human Rights, at the centre of the discussions of its 3rd meeting to be held on 8-10 December 2009 in Strasbourg.

## **INTRODUCTION**

1. The Group of Specialists on the child-friendly justice (CJ-S-CH) held its first meeting in Strasbourg on 16-17 April 2009, with Mr. Séamus CARROLL as Chair and Ms Ksenija TURKOVIĆ as Vice-chair. The list of participants appears in Appendix I to this report.

### **I. OPENING OF THE MEETING**

2. The meeting was opened by Mr. Carroll who welcomed the new participants, Mrs. Annachiara CERRI from the European Committee for Social Cohesion (CDCS), Mrs. Leda KOURSOUNBA from the European Network of Ombudspersons for Children, Ms Lise LEHRMANN from the Ministry of Justice and the Police, Norway, Isabella MATROPASQUA from the Ministry of Justice, Italy and Mrs. Agata ROGALSKA-PIECHOTA from the Ministry of Foreign Affairs, Poland.
3. Ms Regina JENSDOTTIR, Secretary of the CJ-S-CH and Head of Public and Private Law Division was excused.
4. Ms Sabrina CAJOLY, Co-Secretary of the CJ-S-CH, Public and Private Law Division, Directorate General of Human Rights and Legal Affairs, reported on the follow-up given to the 1st meeting and informed the members of the group in particular of the following:
  - the Compilation of existing European and international standards relevant to children's rights has been finalised and made available to the members of the Group;
  - the 1st draft of the Guidelines on child-friendly justice has been sent out to the members of the Group for comments;
  - member states, NGOs and stakeholders have been invited to provide examples of good practice. This invitation is extended to 22 November 2009.
  - the members of the group of experts are encouraged to visit the website of CJ-S-CH, to take note of new material and examples of good practices posted since the 1st meeting, new profiles of members and to use the collaborative space.

### **II. ADOPTION OF THE AGENDA**

5. The agenda was adopted as set out in the Appendix II.

### **III. PRESENTATION ON THE YOUTH CRIME DEVELOPMENTS IN THE UNITED KINGDOM**

6. Mr. Bob ASHFORD, Head of Youth Justice Strategy, Youth Justice Board (YJB) for England and Wales started his presentation by pointing out YJB's role as an adviser regarding youth justice to the Secretary of State. He reported that there is a rise in female offenders and a continuing abuse of alcohol by young people, which often leads to offences.
7. To counteract these developments Youth Offending Teams have been set up, using local structures to work with different agencies and to strengthen the relationship between the local community, the police and judges and thus avoid children being sentenced to

custody. Almost half of the offences are settled before going to court. Due to the Crime and Disorder Act of 1998 the time delay between the offending act and the trial is becoming much shorter.

8. Mr. Ashford stressed the importance of early intervention and explained the "Triple Track Approach" which aims at the re-integration of the perpetrator, child-friendly justice and a balance between justice for victims and offenders.
9. The presentation was followed by a debate, during which the members of the group of experts agreed on the importance of associating the parents of an offender in any possible way regarding the Convention for the Protection of Human Rights and Fundamental Freedom.

#### **IV. WORK ON THE 1<sup>ST</sup> DRAFT OF THE COUNCIL OF EUROPE GUIDELINES ON CHILD-FRIENDLY JUSTICE**

10. Ms Ankie VANDEKERCKHOVE, Scientific expert of the CJ-S-CH, pointed out the need to clearly define whether the guidelines should take into account all legal proceedings involving children, for instance children in custody.
11. She thanked those involved for the examples of good practices received but also explained that not all of them can become part of the guidelines. The group of specialists agreed that it is not their place to give approval to the examples of good practice, as a substitute for extensive research.
12. Ms. Vandekerckhove also mentioned the possibility of consulting children on the guidelines and the search for ways to accomplish this. Regarding this matter, the opportunity of preparing a child-friendly version of the guidelines was discussed.
13. Mr. Carroll invited the members of the group for general comments on the 1st draft of the guidelines. The members agreed on the term "children" instead of "children and young people". It was also agreed that the guidelines should include pre-dating court proceedings and alternative measures, bearing in mind the mandate of this group to create a practical working method for the member states of the Council of Europe. It was also decided to make clear references to existing guidelines and to base the guidelines for child-friendly justice on the extensive case law of the European Court of Human Rights.
14. The Group also emphasised that the right of children to access a court (even international courts like the European Court for Human Rights) is one of the key points of the guidelines. The need for parental approval regarding the validation of each judicial act of the child was comprehensively discussed.
15. It was also agreed that the guidelines should include a chapter about the interaction between children and the police.
16. Children, whether as victims or as offenders, should be guaranteed the same rights as adults, but at the same time the special needs of children due to their vulnerability

because of their age and understanding should be noted. It was also stated that any violation of children's rights, especially bodily harm should be treated as a crime *ex officio*. Any punitive measures taken should be in relation to the offence and the age of the offender.

## **V. PRESENTATION OF THE WORK OF OTHER COUNCIL OF EUROPE BODIES**

17. Mrs. Liubov SAMOKHINA, Programme Advisor "Building a Europe for and with Children" program, Social Cohesion joint Programme, gave a report on the work and upcoming events related to the programme. A brochure for children is being created in light of the 20th anniversary of the Convention on Children's Rights which is being celebrated 20 November 2009. This brochure will soon be available in several languages and distributed in schools and other places visited by children.
18. The launch of the child rights platform took place on 2-3 June. Guidelines on the protection of children against violence have been drafted and sent to the Committee of Ministers for adoption. These guidelines could be used as reference point for local and regional strategies and projects against violence.
19. There will be a meeting of a new *ad hoc* adviser group in Helsinki at the beginning of December 2009. The main objective of this group will be to review existing recommendations and to devise guidelines on child participation on a regional and local level. This group will be composed of ten experts. It is an open group, so participation by CJ-S-CH members is welcome.

## **VI. ADDRESS BY THE HEAD OF DEPARTMENT FOR LAW REFORM**

20. Mr. Jörg POLAKIEWICZ, Head of the Law Reform Department, Directorate General of Human Rights and Legal Affairs (DG-HL) emphasised the importance of the guidelines on child-friendly justice and the proposal of remedial solutions regarding lacunae in law and practice. He was confident with respect to a possible extension of the terms of reference of CJ-S-CH by the Committee of Ministers.

## **VII. PREPARATION OF THE NEXT MEETING**

21. The updated draft text of the guidelines will be submitted to the members of the group of specialists by 19 October 2009 and posted on the website of the CJ-S-CH. The members of the group are invited to submit their comments on this updated draft at their earliest convenience.
22. On 7 December 2009, a hearing of all relevant partners will be organised, possibly in cooperation with ENOC. The list of NGOs and stakeholders to be invited to this hearing is not yet complete.
23. The next consultation of all partners will be in written form.
24. The new draft of the guidelines in light of the comments made by the experts will be made available on the website of the CJ-S-CH as soon as possible before the hearing.

25. The members of the group were invited to propose solutions regarding the consultation of children on the guidelines. It was suggested to use the ENOC's platform for this. A draft questionnaire is to be produced in time for the next meeting of the CJ-S-CH on 8-10 December 2009.
